1. ADOPTION OF THE AGENDA

The first item on the provisional agenda is its adoption. The Joint Meeting will also have before it the report on the September 2002 session (TRANS/WP.15/AC.1/90-OCTI/RID/GT-III/2002-B and addenda).

The following points should be borne in mind:

- (a) At its last session in 2002, the Joint Meeting elected Mr. C. Pfauvadel (France) as Chairman and Mr. H. Rein (Germany) as Vice-Chairman for 2003;
- (b) UN/ECE documents (other than agendas or reports) with the symbol TRANS/WP.15/AC.1/ are circulated by OCTI in German under the symbol OCTI/RID/GT-III/ followed by the same document number. As part of the secretariat's efforts to reduce expenditure, documents distributed prior to the session by mail will not be available in the conference room for distribution to session participants. Delegates are kindly requested to bring their copies of documents to the meeting;

(c) The documentation will be available on the UN/ECE web site (www.unece.org/trans/danger/danger.htm) in English, French and Russian;

(d) The Joint Meeting would possibly, if necessary, like an ad hoc working group to meet concurrently with it on 24 and 25 March to consider documents concerning tanks (item 2), after the item has been discussed in plenary;

(e) An ad hoc working group is scheduled to work outside the times of the plenary session to consider documents concerning standards (item 3), in accordance with the mandate to be decided by the Joint Meeting (see TRANS/WP.15/AC.1/88-OCTI/RID/GT-III/2002-A, paras. 94 and 95).

A first meeting of this group will be held from 14 to 16 January 2003 to consider standards and draft standards for gas receptacles and tanks (see TRANS/WP.15/AC.1/90-OCTI/RID/GT-III/2002-B, para. 22).

5. HARMONIZATION WITH THE UNITED NATIONS MODEL REGULATIONS ON THE TRANSPORT OF DANGEROUS GOODS

The Committee of Experts on the Transport of Dangerous Goods and on the Globally Harmonized System of Classification and Labelling of Chemicals of the United Nations Economic and Social Council met on 11 and 12 December 2002 and adopted a new series of amendments to the United Nations Model Regulations (ST/SG/AC.10/29/Add.1-2) which will be incorporated into the thirteenth revised edition of the Recommendations on the Transport of Dangerous Goods and the fourth revised edition of the Manual of Tests and Criteria.

As agreed at the last session (TRANS/WP.15/AC.1/90, para. 72 and TRANS/WP.15/AC.1/89, item 9), the secretariat will prepare proposals for the harmonization of RID/ADR/ADN on the basis of the decisions taken by the United Nations Committee of Experts. These proposals will receive preliminary consideration from a small working group of the Joint Meeting which will meet in Geneva, at the Palais des Nations, from 26 to 28 May 2003, and will prepare the final documents to be considered by the Joint Meeting in September 2003.

The Joint Meeting may possibly wish to determine the composition of this small working group.
