Information on work in progress in CEN

Transmitted by the European Committee for Standardisation (CEN) 1,2

- 1. As agreed at the September 2005 session, the CEN consultant will advise the Joint Meeting of work in progress in CEN which will result in standards intended to be referenced in the RID/ADR/ADN.
- 2. With respect to the CEN work programme, the Joint Meeting may wish to note that the national members of CEN have, in the context of the systematic review which takes place every 5 years, agreed to keep a large number of standards referenced in RID/ADR/ADN unchanged. In some cases, technical committees of CEN have decided to revise standards in order to take account of technical progress or to consider the comments made by members of the Joint Meeting Working Group on Standards. Revised versions will and are submitted to the Standards Working Group to prepare decisions on amended references.

- 3. No new item on new subjects has been added to the work programme, except that CEN/TC 23 agreed to develop and publish three Technical Specifications to include the texts of Directives 84/525/EEC, 84/526/EEC and 84/527/EEC, which are currently referenced in section 6.2.4 of RID/ADR since their repeal has been announced.
- 4. Members of the Joint Meeting are invited to make national standardizing bodies aware of this process and to encourage them to take part in the standardizing and revision processes.
- 5. Since the last session of September 2008, three dispatches of draft standards were made for consultation by members of the Joint Meeting on the dedicated CEN webpage. Nine of these draft standards are at Step 2 and three at step 3 of the approval process. Members of the Joint Meeting may send their comments using the model reproduced in the annex hereto (English only) to the CEN consultant at karol_wieser@yahoo.de before end of January 2009.
- 6. All comments will be consolidated in a revision to this document which will be distributed again and be reviewed by the Joint Meeting Working Group on Standards during the March 2009 session.
