**INDIA'S COMMENTS ON PROPOSAL FOR CORRIGENDUM TO GTR 2VIDE  
DOCUMENT ECE-TRANS-WP29-GRPE-2009-02**

**A. Proposal:**

India proposes that the corrigendum covered by Proposal A1 for rewriting the tables A5-1 to A5-30 of Annex A5 of GTR2 to be corrected

India supports the corrigendum covered by Proposal A2 for the changes in the gear shifting methodology.

**B. Justification:**

The proposed corrigendum covers the following two changes:

1. Inclusion of the classes of vehicles applicable to each table, e.g.

“Table A5-9: Cycle part 2, reduced speed for **vehicle class 2-1** , 1 to 180 s”

Suggested change : Cycle part 2, reduced speed, 1 to 180 s

Proposal for an alternate test procedure for Class 2-1 motorcycles by using Part 1 reduced speed cycle for hot condition instead of Part 2 Reduced Speed cycle is under consideration. The applicability of different cycles for different classes of vehicle is already being covered by the text of the GTR. India feels that duplicating the information of applicability of the cycles for different vehicle classes in the title of the table shall not be incorporated.

2. Rewriting of the tables to make it more compressed.

While transcribing the tables, rounding errors have crept in the tables, inadvertently, which are tabulated in the next page.

Even though these differences are only to the tune of 0.1km/h and would not affect the emission results, it becomes necessary to update all the programmes already set up for testing, based on the existing tables.
