### 2. UNECE Inland Transport Committee and its subsidiary bodies

2. The Working Party may wish to be informed of the results of the seventy-second session of the ITC (23-25 February 2010), in particular of its considerations and decisions relating to 2010 E-road and E-rail traffic censuses, port hinterland transport, as well as of any other activities of its subsidiary bodies and the UNECE secretariat of interest to the Working Party.

3. During its last session, the Inland Transport Committee **approved** as a whole the report and related activities of the Working Party on Transport Statistics in 2009 (ECE/TRANS/WP.6/157).

### 3. Methodological development and harmonization of transport statistics

#### (a) Classification system for transport statistics

4. At its sixtieth session, the Working Party invited its chairman, Eurostat and the secretariat to examine CPA codes that, according to document ECE/TRANS/WP.6/2009/4, seemed to be lacking in the NST 2007 Groups, and to report back to WP.6 at the present session.

5. The Working Party may wish to consider the document prepared by the chairman, Eurostat and the secretariat as requested (ECE/TRANS/WP.6/2010/1). Delegates were invited to inform the Working Party of their experiences on the use of NST 2007.

#### (b) Glossary for Transport Statistics

**(e) Transport of gas through pipelines**

11. The Intersecretariat Working Group was invited to prepare a pilot questionnaire on transport of gas through pipelines based on recommendations of the Informal Meeting on Transport Statistics (ECE/TRANS/WP.6/157, para. 29).

12. The Working Party may wish to consider the draft of the pilot questionnaire prepared by the IWG (ECE/TRANS/WP.6/2010/4).

**(f) Pilot questionnaire on road traffic performance**

13. At its last session, the Working Party decided to consider the results of the pilot questionnaire on road traffic performance (ECE/TRANS/WP.6/157, para. 31).

14. The Working Party may wish to consider the results of a Task Force organized by Eurostat on the pilot questionnaire on road traffic performance (ECE/TRANS/WP.6/2010/5).

**(g) Statistics on passenger transport by buses and coaches**

15. At its last session, the Working Party approved the pilot questionnaire on passenger transport by buses and coaches to be circulated before the end of 2009 (ECE/TRANS/WP.6/157, para. 19). The Working Party may wish to be informed about the delay of this activity.

**(h) Statistics on hinterland connections of seaports**

16. The Working Party may wish to be informed about the activities of the Group of Experts on Hinterland Connections of Seaports (ECE/TRANS/WP.5/GE.1/7).

17. During its last session, the Inland Transport Committee **approved** the report on hinterland connections of seaports (ECE/TRANS/210), and **invited** the Working Party on Transport Statistics to consider whether and how the statistical recommendations could be implemented.

18. The Working Party may wish to review best practices in the collection of data on port hinterland traffic and consider methodologies and mechanisms to possibly collect such data in the UNECE region.

**(i) Passenger accessibility of heavy rail systems**

19. During its last session, the Inland Transport Committee **endorsed** the policy statement on passenger accessibility of heavy rail systems adopted by the Working Party on Rail Transport (ECE/TRANS/SC.2/212, annex III) and **invited** the Working Party on Transport Statistics to consider whether and how it could collect the data needed to quantify social benefits of accessibility measures.

20. The UNECE Working Party on Transport Statistics was encouraged to explore the possibility of collecting information on passenger accessibility of heavy rail systems for UNECE member States in close cooperation with the ITF, Eurostat and national statistical authorities.

21. The Working Party may wish to consider this issue on the basis of a document submitted by the European Railway Agency (ECE/TRANS/WP.6/2010/8).

**(j) Modernizing statistical production**

22. The Working Party may wish to be informed by the secretariat (UNECE Statistical Division) about providing generic terms for statistical production. This activity is related to the Common Metadata Framework (CMF) prepared by the Joint UNECE / Eurostat / OECD Work Sessions on Statistical Metadata (METIS).

**4. Traffic censuses in the United Nations Economic Commission for Europe region**

**(a) 2010 E-Road traffic census**

23. During its last session, the Inland Transport Committee **invited** UNECE member States to take part in the 2010 E-Road traffic census in compliance with ITC Resolution No. 259 and to inform the secretariat whether they agree to do so.

24. The Working Party will be informed about the status of the 2010 E-Road traffic census Informal document WP.6 No. 2 (2010).

**(b) 2010 E-Rail traffic census**

25. During its last session, the Inland Transport Committee **invited** UNECE member States to take part in the 2010 E-Rail traffic census in compliance with ITC Resolution No. 260 and to inform the secretariat whether they agree to do so.

26. The Working Party will be informed about the status of the 2010 E-Rail traffic census Informal document WP.6 No. 3 (2010).

33. The Working Party may wish to be informed on dates and locations of upcoming meetings on transport statistics in 2010-2011.

35. The next session of the Working Party is tentatively scheduled to be held at the Palais des Nations in Geneva on 1-3 June 2011.
