
## Introduction

1. At the thirty-seventh session of the Sub-Committee, an alternative proper shipping name CARTRIDGES FOR TOOLS, BLANK for UN 0014 was provisionally approved in square brackets. The proposal enjoyed the unanimous support of the Working Group on Explosives.

2. The reason for provisional approval was based on a request by a member of the Working Group on Explosives to check with European industry relative to the potential impact on non-transport regulations.

3. In accordance with this request, on 28 July SAAMI met with CEN/TC212's Project Group "Fixing Cartridges" to explain the work of the Sub-Committee on this matter. The Group supported the action of the Sub-Committee, but requested that the proper shipping name be modified to "Cartridges, blank, for industrial use". This proper shipping name will align with non-transport systems currently in use. This request has no adverse effect on transport and can be accepted.

## **Proposal**

4. Modify the dangerous goods list in Chapter 3.2 and amend the provisionally approved proper shipping name as follows:

Change the wording of the entry for "Cartridges, blank" in the glossary of terms in Appendix B as follows: "Articles which consist of a cartridge case with a centre or rim fire primer and a confined charge of smokeless or black powder but no projectile. Used for training, saluting or in starter pistols, <u>industrial use</u>, etc.".
