# **Unannounced inspections with sampling during manufacturing of pressurized containers**

Transmitted by the Government of France<sup>1,2</sup>

*Summary* 

Executive summary: This document is intended to add a requirement for the relevant bodies to

undertake unannounced inspections with sampling throughout the

manufacturing process for pressurized containers.

**Action to be taken**: Add a new provision to 1.8.7.3.

#### Introduction

- 1. Pursuant to 1.8.7.3.3, "The relevant body shall:
- (a) Verify the conformity with the technical documentation specified in 1.8.7.7.2;
- (b) Verify that the manufacturing process produces products in conformity with the requirements and the documentation which apply to it;
- (c) Verify the traceability of materials and check the material certificate(s) against the specifications;
- (d) As applicable, verify that the personnel undertaking the permanent joining of parts and the non-destructive tests are qualified or approved;
- (e) Agree with the applicant on the location where the examinations and necessary tests are to be carried out; and
  - (f) Record the results of its survey."
- 2. With a view to improving the safety of pressurized containers, we would suggest adding an additional requirement for the relevant bodies, requiring them to undertake unannounced inspections of the manufacturers, with sampling and testing, throughout the manufacturing process. We have recently encountered problems relating to the conformity of some valves that in our opinion could have been avoided if such a requirement existed. It is important to act based on our experience in the field.
- 3. The measures set out in 1.8.7.3 do not call for unannounced inspections with sampling, which would ensure verifications as stipulated by 1.8.7.3.3 (b).
- 4. Accordingly, we suggest adding an additional clause to 1.8.7.3.

## **Proposal**

- 5. In RID/ADR, add to 1.8.7.3 a new 1.8.7.3.4, to read as follows:
  - "1.8.7.3.4 In order to ensure that products are in conformity with the requirements and the documentation which apply to them, the relevant body shall undertake, at least once a year, unannounced inspections of the manufacturer's facilities, including sampling and testing, throughout the manufacturing process for pressurized containers."

#### **Justification**

Safety: The proposal is being made in response to problems identified

in France relating to the conformity of valves. The proposal

will make pressurized containers safer.

Feasibility: No problem

Practical implications: Ensure implementation of certain compulsory verifications set

out in 1.8.7.3.3.
