

Update of Annex III to document ECE/TRANS/WP.29/343/Rev.19

Annex III

Unilateral application of certain Regulations

Canada

At the one-hundred-and-fifty-third session of the World Forum (ECE/TRANS/WP.29/xxx), the representative of Canada stated that his Government was applying the technical provisions of several Regulations listed below. In some cases, technical provisions of these Regulations are applied to a specific type of vehicle; in other cases only selected provisions or a specified part or revision of the Regulation would apply. As well, some of the technical provisions are accompanied with additional prescriptions. In most cases, the Regulations are offered as alternatives to the requirements of Canada Motor Vehicle Safety Standards.

Square brackets indicate Regulations that are in process of being added as reference.

Regulation No. 8, Uniform Provisions Concerning the Approval of Motor Vehicle Headlamps Emitting an Asymmetrical Passing Beam or a Driving Beam or Both and Equipped with Halogen Filament Lamps (H1, H2, H3, HB3, HB4, H7, H8, H9, HIR1, HIR2 and/or H11);
