

INFORMAL GROUP MEETINGS SCHEDULED TO BE HELD
IN CONJUNCTION WITH THE 64th GRPE SESSION PROPER
(INCLUDING THE ROOM RESERVATIONS – SEE ANNEX)

The sixty-fourth session of the Working Party on Pollution and Energy (GRPE) was initially scheduled to be held from 17 (p.m.) to 20 (a.m.) June 2012. However, during its last session (ECE/TRANS/WP.29/GRPE/63, para. 81), GRPE decided to start the session on Monday afternoon, 4 June 2012, with the informal meetings (without interpretation) and to conclude on Friday afternoon, 8 June 2012. Nevertheless, no meetings will be held on Monday 4 June 2012, due to the lack of rooms available. Full interpretation will only be provided in Room XXI from Thursday morning to Friday morning. The GRPE session proper is expected to start on Thursday, 7 June 2012 at 9.30 a.m., and conclude on Friday, 8 June 2012 at 12.30 p.m. **It will be followed by the first meeting of the Informal Working Group on Electric Vehicles and Environment (EVE), until 12.30 p.m. On Friday afternoon, 8 June 2012, from 14:00 to 18:30, the European Commission is also holding a stakeholder consultation workshop on the revisions and amendments of international L-category vehicle requirements in the area of environmental and propulsion performance.**
