### Accidents database

#### Introduction

1. The idea to develop an accident database has been raised at several occasions during working group meetings as well as in the plenary joint meeting. During the different sessions of the BLEVE working group it appeared that working on systematic and exhaustive accident data could be very useful but that, unfortunately, the current situation in accident reporting was still too limited to allow all the benefits deriving from that approach.

2. Following the discussions held at the last session of the joint meeting, the secretariat and the french delegation worked together on the basis of the report, document TRANS/WP.15/AC.1/128 paragraphs:

*“64. The Joint Meeting recognized that, the provisions of 1.8.5.2 notwithstanding, the Contracting Parties to RID/ADR/ADN provided only very little information to the secretariat on accidents/incidents arising in the transport of dangerous goods. The number of accidents attributable to the dangerous goods themselves was low, which demonstrated the effectiveness of the regulations, but a more systematic analysis of incidents or accidents would still be beneficial for improving safety.*

*65. The representative of France presented a database of accidents occurring in France during the transport of dangerous goods and proposed to make it available to the secretariats so that they could fill it in with data from other countries. Several delegations said that they were prepared to provide data. The database could be maintained by the secretariats. A pilot project could be set up in cooperation with France, the secretariats and delegations expressing an interest. The Joint Meeting would raise the matter again at the next session to clarify how such a project for collecting and analyzing data on accidents/incidents should be maintained.*

3. The results of that cooperation allowed to achieve the following points:

- (a) It is confirmed that it is easy to consolidate data coming from different origins if they are presented under the same structure of a Microsoft access database;
- (b) The structure of the initial database has been modified to be suitable for use in an international context. It follows the structure of the mandatory accident report in 1.8.5. The language is English;
- (c) To use the database fully it is necessary to get the Microsoft access software, nevertheless the secretariat can provide an “auto-run” software that allows to fill in

the database even without having Microsoft Access. However this auto-run doesn't allow to create queries to get "on demand" information out of the full consolidated database;

(d) Filling in the database is easy (interfaces are presented in the annex). Interrogating the database with queries requires some knowledge and training for the use of Microsoft Access, however pre-established queries may be designed as deemed appropriate;

(e) The minimal computer configuration for this to work is: a PC with Windows XP SP3, 2 GB RAM, 50 MB disk space, Microsoft Access 2000 or Microsoft Access 2010 Runtime.

## Proposal

4. It is proposed to launch a pilot experiment under the following conditions:
  - (a) The database uses Microsoft Access which is a standard software suitable for the intended use, and can be found easily at a reasonable price;
  - (b) The charge of getting Microsoft Access stay with each competent authority;
  - (c) The structure of the database would be given to any competent authority willing to cooperate. Ideally we hope for the largest participation;
  - (d) If one doesn't have Microsoft Access immediately it is still possible to start participating by using Microsoft Access 2010 Runtime, an application distributed free of charge by Microsoft, keeping in mind that it doesn't allow full access to the data;
  - (e) Each competent authority participating in the project commits to fill the database with the accidents happening on its territory, as comprehensively as possible;
  - (f) The working language should be English (in principle at this stage language should not be a big issue as most of the fields other than the commentaries are already numbered or codified);
  - (g) At a defined date the completed database files are sent by each participating competent authority to the UNECE secretariat. The secretariat will consolidate all the files into one global database that will be given back to each of the participants in the experiment.
5. As this is only a first experiment we think that it may not be important to stick precisely to one calendar year. We propose to start as soon as possible after this session of the joint meeting.
6. The lessons learned from the experiment shall be presented to the joint meeting in march 2014. Therefore the different national databases shall be sent to the secretariat for consolidation at the end of January 2014 even if reports concerning some events from 2013 are missing.
7. If this is helpful an intermediate evaluation could be made at the September session of the Joint Meeting. This could help to identify possible difficulties and decide upon appropriate corrective actions if necessary.
8. Based on the conclusion of the experiment the joint Meeting will be able to decide on the best way to go on with it.

9. Some thoughts should be given in the interim period on how the data base could be made available on the UNECE and OTIF secretariats websites. In particular this needs to address issues related to data protection, access control, general computer security ...
