1. Page 2, amendment to Part 1, Chapter 1.1, 1.1.3.6.3, in the second indent

After compressed gases insert , adsorbed gases

2. Page 2, amendment to Part 1, Chapter 1.1, 1.1.3.6.5

For and 1.1.3.9 read , 1.1.3.9 and 1.1.3.10

3. Page 6, amendment to Part 1, Chapter 1.6, new transitional measure 1.6.2.13

For the existing text, *substitute*

1.6.2.13 Bundles of cylinders manufactured before 1 July 2013 which are not marked in accordance with 6.2.3.9.7.2 and 6.2.3.9.7.3 applicable from 1 January 2013 or 6.2.3.9.7.2 applicable from 1 January 2015 may be used until the next periodic inspection after 1 July 2015.

4. Page 6, amendment to Part 1, Chapter 1.6, new transitional measure 1.6.3.44

For the existing text, *substitute*

1.6.3.44 Fixed tanks (tank-vehicles) and demountable tanks intended for the carriage of UN Nos. 1202, 1203, 1223, 3475 and aviation fuel classified under UN Nos. 1268 or 1863, equipped with additive devices designed and constructed before 1 July 2015 in accordance with national provisions, but which do not, however, conform to the construction, approval and testing requirements of special provision 664 of Chapter 3.3

applicable as from 1 January 2015, may continue to be used until their first intermediate or periodic inspection after 31 December 2015. After this date, they shall only be used with the agreement of the competent authorities in the countries of use.

8. Page 27, amendment to Part 3, Chapter 3.3, SP594

For the existing text, *substitute*

SP 594 Amend to read as follows:

"594 The following articles, manufactured and filled according to the provisions applied in the country of manufacture, are not subject to the requirements of ADR:

(a) UN No. 1044 fire extinguishers provided with protection against inadvertent discharge, when:

- they are packaged in a strong outer packaging; or
- they are large fire extinguishers which meet the requirements of special packing provision PP91 of packing instruction P003 in 4.1.4.1;

(b) UN No. 3164 articles, pressurized pneumatic or hydraulic, designed to withstand stresses greater than the internal gas pressure by virtue of transmission of force, intrinsic strength or construction, when they are packaged in a strong outer packaging.

NOTE: *"Provisions applied in the country of manufacture" means the provisions applicable in the country of manufacture or those applicable in the country of use."*

9. Page 32, amendment to Part 3, Chapter 3.3, new special provision SP663, after the third indent under "Scope"

- 11. Page 38, amendment to Part 4, Chapter 4.1, 4.1.4.1, packing instruction P200, new paragraph (13), sub-paragraph 1.3, after the third indent**

- 13. Page 64, amendment to Part 5, Chapter 5.5, new paragraph 5.5.3.1.5, last sentence**

- 14. Page 66, last amendment to Part 6, Chapter 6.2, 6.2.2.1.1**

For the existing text, *substitute*

For ISO 7866:1999, in the column "Applicable for manufacture", add "Until 31 December 2020" and for all the other standards, in the column "Applicable for manufacture", add "Until further notice".

- 15. Amendments to Part 6, Chapter 6.2, 6.2.2.10, 6.2.2.11, 6.2.3.6.1, 6.2.4.1 and 6.2.4.2, in the French text**

- 16. Page 70, amendment to Part 6, Chapter 6.2, 6.2.3.9.7**

For the existing text, *substitute*

6.2.3.9.7 Amend to read as follows:

"6.2.3.9.7 Marking of bundles of cylinders

6.2.3.9.7.1 Individual cylinders in a bundle of cylinders shall be marked in accordance with 6.2.3.9.1 to 6.2.3.9.6.

6.2.3.9.7.2 Marking of bundles of cylinders shall be in accordance with 6.2.2.10.2 and 6.2.2.10.3, except that the United Nations packaging symbol specified in 6.2.2.7.2 (a) shall not be applied.

6.2.3.9.7.3 In addition to the preceding marks, each bundle of cylinders that meets the periodic inspection and test requirements of 6.2.4.2 shall be marked indicating:

(a) The character(s) identifying the country authorizing the body performing the periodic inspection and test, as indicated by the distinguishing sign of motor vehicles in international traffic³. This marking is not required if this body is approved by the competent authority of the country approving manufacture;

(b) The registered mark of the body authorised by the competent authority for performing periodic inspection and test;

(c) The date of the periodic inspection and test, the year (two digits) followed by the month (two digits) separated by a slash (i.e. "/"). Four digits may be used to indicate the year.

The above marks shall appear consecutively in the sequence given either on the plate specified in 6.2.2.10.2 or on a separate plate permanently attached to the frame of the bundle of cylinders."

The text of footnote 3 read as follows: "³ Distinguishing signs for motor vehicles in international traffic prescribed in the Vienna Convention on Road Traffic (1968)."

17. Page 70, amendment to Part 6, Chapter 6.2, 6.2.4.1, new entry for standard "EN ISO 3807:2013", in column (2), after the title of the standard

Insert

NOTE: *Fusible plugs shall not be fitted.*

18. Page 70, before the amendment to Part 6, Chapter 6.2, 6.2.4.1, concerning the insertion of standard "EN ISO 11120:1999 + A1:2013"

Insert

– For standard "EN ISO 11120:1999", in column (4), replace "Until further notice" by "Between 1 July 2001 and 30 June 2015".

– For standard "EN ISO 11120:1999", in column (5), add the following new text: "31 December 2015 for tubes marked with the letter "H" in accordance with 6.2.2.7.4 (p)".

19. Page 73, second amendment to Part 6, Chapter 6.4, 6.4.6.4 (starting with "In (a) and (b)...")

6.4.6.4 In (a) and (b) delete "The packages are designed".

6.4.6.4 In (a), add "and/or" at the end and in (b), replace "or" by "and/or".
