#### 1. Adoption of the agenda

The first item on the agenda concerns its adoption. The Joint Meeting will also have before it the report on its spring 2015 session, held in Bern from 23 to 27 March 2015 (ECE/TRANS/WP.15/AC.1/138 – OTIF/RID/RC/2015-A and Add 1).

The following points should be borne in mind:

- (a) At its autumn 2014 session, the Joint Meeting elected Mr. C. Pfauvadel (France) as Chairman and Mr. H. Rein (Germany) as Vice-Chairman for 2015;
- (b) UNECE documents (other than agendas or reports) with the symbol ECE/TRANS/WP.15/AC.1/ are circulated by the Intergovernmental Organisation for International Carriage by Rail (OTIF) in German under the symbol OTIF/RID/RC/followed by the same document number. As part of the secretariat's efforts to reduce expenditure, documents will not be available in the conference room. Delegates are kindly requested to bring their copies of documents to the meeting;
- (c) The documentation will be available on the UNECE website (www.unece.org/trans/danger/danger.htm) in English, French and Russian;
- (d) The Joint Meeting would, if necessary, like an ad hoc working group to meet outside the times of the plenary session to consider documents concerning standards (item 5), in accordance with the mandate to be decided by the Joint Meeting;



- The Joint Meeting would, if necessary, like an ad hoc working group to meet (e) concurrently with it to consider documents concerning tanks (item 6), after this item have been discussed in plenary;
- As Wednesday, 23 September 2015 is a holiday at the United Nations, there will be no interpretation on that day, which will be reserved for the working groups and perhaps the reading of those parts of the draft report that are available. The working groups on tanks and standards will meet in the second week. The reading of the report, or of the end of the report, will take place on Friday, 25 September, without interpretation.
