I. Proposal

Annex 17, paragraph 1.2., correct to read:

- "1.2. A child restraint system of the universal category means a child restraint approved to the "universal" category of UN Regulation No. 44, Supplement 5 to 03 series of amendments (or subsequent amendments). Seating positions, which are indicated by the vehicle manufacturer as being suitable for the installation of child restraints systems of the universal category shall comply with the provisions of Appendix 1 ~~and Appendix 5~~ to this annex."

II. Justification

1. Corrigendum of paragraph 1.2: Deletes "and Appendix 5" to align with the text of Supplement 9 to the 06 series of amendments to UN Regulation No. 16.

2. Corrigendum of Table 1: Deletes "F1" in the table, as this fixture is part of corresponding ISO Standard but not in UN Regulation No. 16.
 3. Appendix 5: Replaces "universal" by "i-size" in the title of Appendix 5, as UN Regulation No. 129 booster seats can be only i-Size or specific.
