The “Strengthening of the national road safety management capacities of selected developing and countries with economies in transition” project aims to help beneficiary Governments to identify the most critical road safety aspects and priority needs by preparing Road Safety Performance Reviews and offer capacity building training in the identified areas. In that sense the Project will assist countries to enhance national road safety management capacities. Furthermore, the Project aims to help countries to raise public awareness on road safety issues and sensitize public and non-governmental sectors on the need to set ambitious road safety targets and adopt specific measures to meet them.

The Final Road Safety Performance Review Capacity Building Workshop will be initiated by policy dialogue with national road safety stakeholders on how to use Road Safety Performance Review recommendations to generate road safety actions. Second part of the capacity-building workshop will be dedicated to road safety statistics (methodology, data collection, dissemination and publishing) and its role in achieving UN Sustainable Development Goals (SDGs). The objective is to provide information and best practice for national government officials and other road safety stakeholders (NGO, academia, private sector) from Albania and Georgia.

During 1.5 days event, the following will be discussed:

- Recommendations of the Road Safety Performance Reviews and how to use them to improve road safety management,
- Road safety statistics (collection, definition, indicators),
- Transport-related Sustainable Development Goals.

During the workshop, a final draft of the Road Safety Performance Reviews will be presented.
