**SUBJECT: European Agreement concerning the International Carriage of Dangerous goods by Inland Waterways ADN: Recognition of classification societies according to sub-section 1.15.2.4.**

Dear madam, dear sir,

The Ministry of the Sea, Transport and Infrastructure of Croatia presents its compliments to the ADN Administrative Committee of the UN Economic Commission for Europe and has to honour to address with the following.

Taking into consideration entering of the Croatian Register of Shipping into the list of classification societies, based on the subsection 1.15.2.4. of Annexed Regulation to the European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN), after the "Croatian Register of Shipping" has fulfilled the recognition procedure, confirmed by the decision of the Administrative Committee on session in Geneva 25th January this year, about recognition of the classification society "Croatian Register of Shipping" as a recommended ADN classification society, I decide to recognize classification society "Croatian Register of Shipping" by "Decision on Recognition of Classification Company Croatian Registrar of Shipping" from March 4, 2019 (ODLUKA o priznanju klasifikacijskog društva Hrvatski registar brodova od 04. ožujka 2019. godine – in attachment).

The Ministry of the Sea, Transport and Infrastructure has received a request from the Croatian Register of Shipping in which they request recognition of their classification society. After considering the request, and positive decision of ADN Administrative Committee, Ministry of the Sea, Transport and Infrastructure under subsection 1.15.2.4. the Regulations annexed to the ADN, which states that each Contracting Party may decide to recognize the recommended classification society, has decide to recognize Croatian Register of Shipping, which is on the list of recommended ADN classification societies. The Secretariats are kindly

asked to forward the information to the Administrative Committee and the other Contracting Parties in accordance with the regulations of ADN.

I take this opportunity to renew the assurances of its highest consideration to the ADN Administrative Committee of the UN Economic Commission for Europe.
