2. Transport Infrastructure Construction costs: Presentations of good practices at national levels for evaluating and calculating construction costs

GE.4 is expected to continue its discussion on the part of the final report which is to provide an overview of models, methodologies, tools and good practices for evaluating, calculating and analysing inland transport infrastructure construction costs. In this regard, GE.4 will take stock and analyse the inputs received from ECE member States following the dissemination by the secretariat on 22 October 2019 of a set of four open questions aimed at collecting information on good practices.

3. Transport Infrastructure Construction costs: Presentations of terminologies used

GE.4 is expected to continue its discussion on the consolidated list of terminologies for road, rail, inland waterways and intermodal terminals (ECE/TRANS/WP.5/GE.4/2019/1/Rev.1) updated by the secretariat in follow-up to the last session. GE.4 will be invited to consider it in full and endeavour to finalize it at the session.

4. Collection and analysis of benchmarking data

GE.4 is expected to continue its discussion on the part of its final report which should illustrate and describe the benchmarking analysis of the construction costs for the different inland transport networks and nodes. Following the latest dissemination by the secretariat (on 22 October 2019) of the rail and road questionnaires, GE.4 is expected, pending available data, to analyse the replies received since its last session,

Based on the feedback received from the ECE Working Party on Inland Water Transport (SC.3) as well as ECE Working Party on Intermodal Transport and Logistics (WP.24), GE.4 is also expected to discuss and finalise the draft questionnaires on inland waterways and ports and intermodal terminal infrastructure construction costs with the aim of their dissemination to ECE member States for data collection purposes.

5. Discussion on the structure of the final report of the Group of Experts

GE.4 is invited to continue discussing on the structure of its final report, considering the progress made under the above items 2, 3 and 4 of the agenda. The Group's Terms of Reference stipulate the submission of a full report of its accomplishments, including a set of policy-oriented recommendations.
