# EUROPEAN AGREEMENT ON IMPORTANT INTERNATIONAL COMBINED TRANSPORT LINES AND RELATED INSTALLATIONS (AGTC)

New amendment proposals

#### Transmitted by the Government of Latvia

<u>Note</u>: The Working Party may wish to be informed of the following amendment proposals aiming at extending the AGTC combined transport network as well as its related installations to Latvia.

In accordance with the relevant provisions of article 15 of the AGTC, the Contracting Parties to the AGTC may wish to take note of these proposals with a view to preparing an official proposal for consideration and adoption at the next session of the Working Party and to undertake the necessary consultations with the countries directly concerned by these amendment proposals, i.e. Belarus and the Russian Federation. Estonia, Lithuania and Latvia are not yet Contracting Parties to the AGTC (Lithuania has acceded to the AGC in 2002).

The secretariat is of the view that, in addition to these amendment proposals pertaining to Latvia only, the relevant railway links to Belarus, Estonia and the Russian Federation should be identified in the following months. Also other important combined transport lines to from and through Estonia and Lithuania could be identified to allow the Working Party to possibly adopt, at one of its next sessions, a consistent package of new AGTC railway lines and related installation in this sub-region.

To facilitate discussions and understanding of the amendment proposals pertaining to Latvia, the secretariat has reproduced at the end of this document a map showing the Latvian railway scheme.
