ANNOTATED PROVISIONAL PROGRAMME

With deep and complex reforms necessary to build resilient economies yet to be achieved in SPECA participating countries, Agenda 2030 provides a valuable opportunity to revisit development trajectories and effectively implement the Agenda’s sustainable development goals (SDGs). While most SPECA participating countries are developing strategies that mainstream sustainable development into national plans, in addition to establishing institutional coordination and monitoring frameworks, much work remains to be done.

SPECA can serve as a mechanism that promotes policy consistence and coherence across its participating countries. Furthermore, through a subregional consolidation of national assessments, SPECA can serve as a bridge which feeds them into the regional and global follow-up and review mechanism for Agenda 2030.

Consequently, the objective of the 2016 Economic Forum is for SPECA participating countries to take stock of how the subregion is positioning itself in the implementation of SDGs, to assess national SDG strategies and institutional frameworks, and to examine practical approaches and modalities. By developing a baseline in 2016 upon which the subregion stands in terms of SDGs, SPECA participating countries will be in a position to review, measure, and adapt implementation on a cooperative basis, annually, through the year 2030. Furthermore, it would also be desirable to identify and agree on the necessary conditions required for SPECA to function as a unique platform for subregional cooperation.

The recommendations emerging from the 2016 SPECA Economic Forum will be submitted for adoption to the 11th session of the SPECA Governing Council as a “Draft Ganja Declaration on Enhanced Implementation of SDGs through Cooperation”.

10.30 – 12.00 SESSION I: REVIVING AND REBALANCING ECONOMIC GROWTH: REVIEW OF CROSS-BORDER CONNECTIVITY INITIATIVES AND PRIORITY POLICY REFORMS

Reviving and rebalancing growth and trade, with supportive infrastructure connectivity, economic diversification and structural transformation will be critical for implementation of SDGs. Under this agenda item, based on the findings of ESCAP papers, the impacts of deep plunges in commodity prices will be reviewed and lessons drawn by SPECA countries, as will the recent surge in cross-border connectivity initiatives. Policy responses and reforms will be proposed which aim not only at cross-border infrastructure connectivity, but also at market integration, in order to enhance the capacity of SDG implementation through wider connectivity initiatives and the participation of a diversified business sector. Special attention will be paid to the economic integration of Afghanistan through trade, investments, and entrepreneurship development.

12.00 – 13.00 SESSION II: REVIEW OF IMPLEMENTATION OF THE SUSTAINABLE DEVELOPMENT GOALS AT NATIONAL LEVEL

The transformational potential of SDGs needs to be situated within the contextual realities of the seven SPECA participating countries. Furthermore, it is important to base reform

decisions on accurate information and analytical evidence. Towards this end, each participating country will briefly present a country paper that comprehensively outlines the status of SDG mainstreaming in the national policy-planning process, institutional setups, and reforms currently underway. The papers will serve as instruments for factual evidence and information gathering which will help strengthen SPECA as a mechanism for sharing practical approaches and beneficial modalities for action. The papers will also guide the ESCAP and UNECE secretariats in their support to SPECA countries for SDG implementation. Agencies of the UN system and other stakeholders will be invited to briefly present areas in which their programmes can contribute to the SPECA Work Plan for 2016-2017.

Data paucities are large in SPECA participating countries. Therefore, there is an urgent need to map SDG data and indicator readiness against the emerging SDG indicator architecture. Based on ESCAP findings, the discussions under this agenda item will consider how SPECA can serve as a mechanism that identifies gaps in statistics, as well as capacity-building needs for enhanced collection, timeliness, and accessibility of data. Proposals will be also made on how SPECA can promote the sharing of statistics across the subregion, so that a more complete picture of the subregional implementation progress emerges.

16.15 – 17.30 SESSION IV: ENVIRONMENTAL SUSTAINABILITY AND RESOURCE-USE EFFICIENCIES

SPECA participating countries are severely affected by the legacy of overexploitation of natural capital. Energy and water intensity remains very high, the rate of greenhouse gas emissions has increased rapidly over the past decade, and soil degradation is widespread. Thus, the food security, water and energy nexus is particularly strong and therefore challenges the sustainability of development. Under this item, discussion will focus on addressing these interlinkages through the indivisibility of SDGs. Furthermore, the cost-effectiveness of enhancing regional climate change adaptation and disaster risk reduction measures through actions taken on a regional cooperative basis will be considered.

Balancing the three pillars of sustainability – economic, environmental, and social – forms the core of the 2030 Agenda for Sustainable Development. This agenda item will focus on the social pillar of sustainable development. An ESCAP background paper will explore trends for the SPECA participating countries on equality and inclusion, followed by the identification of policy priorities for enhanced equity and social justice. The discussion will include how SPECA can serve as a mechanism to review and assess common and diverse socio-economic challenges and trends with cross-sectoral implications, such as universal social protection systems, institution-building and gender equality, as well as those with cross-border implications such as migration.
