




Product setup process



1. become an e-resident

Application steps. Cost 100€ (state fee)


- 1. Require documents for application (id, photo, master-visa card)
- 2. Submit online application and pay state fee
- 3. Application validation by PPA
- 4. Collect ID card from your selected embassy (34 locations) or in Estonia (ID, biometrics)
- 5. Test your ID card (insert ID number and authenticate)
- 6. Install ID card software and start using services



2. start a company

Company registration online.

- 1. Choose and check your business entity name
- 2. Office registration contact Virtual Office provider for physical address (choose service provider)
- 3. Register a company online and pay state fee 190€
- 4. In case a private limited company is registred pay 2500€ as company share capital (payment can be postponed)
- 5. Open bank account (choose bank) (must travel to Estonia to have f2f meeting with bank)
- 6. Registration of the company as a VAT payer at the ETCB
- 7. Registration of the employees in the employee registry at the ETCB




3. run remotely and digitally administer a company


