Executive Summary

1. Small scaled lodging houses are hotels or any type of facilities where people stay primarily for leisure rather than business. They are usually located in sightseeing areas or any areas considered as leisure spots. There is a large number of this type of lodging facility around the world and they are usually small. Due to the characteristics of their location and the leisure activities provided, the services offered to customers may be quite diversified, varying from one lodging house to another or from one location to another.

2. This document covers the services that a lodging house may provide to customers, which, hereinafter, will be described as lodging house travel products, and serves to supplement the lodging house general information. Customers may search lodging house travel products together with the general lodging house information before they book a stay or visit a lodging house. A customer needs to be well informed about a travel product(s) before a reservation is made.
