-	At its last session, the Commission recognized that ECE's efforts in the Mediterranean had very often failed because of lack of financial resources and, therefore, additional efforts should be made to mobilize resources with a view to responding to the specific circumstances and needs of the Commission's Mediterranean countries. In response to that request, the Executive Secretary invited Governments of the Mediterranean member countries of ECE, ESCWA and ECA to consider possibilities of pursuing joint activities for the benefit of these countries. This issue was discussed at the meeting of the Executive Secretaries of these commissions in New York where the idea was welcomed.
-	Operational activities in the Mediterranean region continued in the field of energy, SMEs, forest industries and statistics. In cooperation with the Italian oil and gas companies, the ECE Gas Centre organised the Mediterranean Gas Conference: Preparing for the Next Era, in Palermo, Italy on 13-14 April 1999. The training workshops were organized in Valetta (Malta), Ramallah and Tunis for the following 12 recipient countries/territories: Algeria, Cyprus, Egypt, Israel, Jordan, Lebanon, Malta, Morocco, Palestinian Authority, Syria, Tunisia and Turkey. Eurostat has asked the ECE to provide additional support of this kind to the project in the coming year. All expenses for the ECE staff member concerned are paid by Eurostat's MEDSTAT-Migration project.
-	ECE has received several suggestions for cooperation on various topics which are under consideration by the secretariat. Among them the following areas are mentioned: agriculture, energy, environment, training, transport and customs, statistics (Italy); air pollution, energy efficiency, trade facilitation (Malta); agriculture, energy, environment including water, legislation, free trade, transport (Turkey).
