##### *Summary*

The General Assembly approved the proposed change from a biennial to an annual budget period on a trial basis (beginning in 2020). The first annual proposed programme budget was prepared for 2020 last year.

Given the decision of the General Assembly, the present document contains a list of planned publications 2021 proposed by the sustainable energy subprogramme on an annual and no longer on a bi-annual basis.

The present document also makes reference to already approved publication plans for 2018-2019 (ECE/ENERGY/2017/13, ECE/ENERGY/13, and ECE/ENERGY/119 – Annex) and 2020 (ECE/ENERGY/2018/8), to which the sustainable energy subprogramme wishes to introduce changes.

The titles of publications provided in this document are preliminary titles.
