FINANCING OF EFFECTS-ORIENTED ACTIVITIES

Note by the Bureau of the Working Group on Effects in collaboration with the secretariat

INTRODUCTION

1. At its twenty-third session, the Executive Body for the Convention reminded Parties of its decision 2002/1 on the financing of core activities (ECE/EB.AIR/77/Add.1, annex I). It took note of the contributions made in 2004 and 2005 to the Trust Fund for core activities not covered by the EMEP Protocol, both those in cash and those in kind made directly to programme centres.

2. In particular, the Executive Body noted that decision 2002/1 had not been effective in attracting the necessary funds for coordinating the core activities not covered by the EMEP Protocol.

3. The Executive Body requested the secretariat to inform Parties of their recommended contributions to meet the 2006 budget, inviting them to make contributions as agreed in decision 2002/1. It also urged all Parties that had not yet done so to consider providing voluntary contributions to the Trust Fund for financing core activities without undue delay. Furthermore, it noted with appreciation the essential support provided to the Convention and its bodies by lead countries, countries hosting coordinating centres and those organizing meetings, as well as countries that funded activities of their national focal centres/points and the active participation of national experts.

4. In keeping with decision 2002/1, the Executive Body decided to adopt, for the core activities not funded by the EMEP Protocol, a budget for 2006 of US\$ 2,152,700 (EB.AIR/2005/2, table 8) and a provisional budget for 2007 and 2008 of US\$ 2,152,700. Contributions to the Trust Fund and the use of those contributions are summarized in sections I and II below.

5. The Executive Body further noted the need to develop the funding mechanism for core activities not covered by the EMEP Protocol. These items were also addressed in the document EB.AIR/2005/2. The secretariat wished to draw attention to some additional details (see section III below).

6. The Bureau of the Working Group on Effects prepared a detailed draft budget for the costs of core activities in 2007 (table 1) and suggested a provisional budget for 2008 and 2009 of US\$ 2,152,700. It agreed that the international coordination priorities focus on the items of the draft 2007 workplan submitted for approval by the Working Group (see section IV below).

I. VOLUNTARY CASH CONTRIBUTIONS IN 2005 AND 2006

7. The voluntary cash contributions towards partly financing the essential coordination of effects-oriented activities that were paid to the Trust Fund in 2005 and 2006 (as of 31 May 2006) are presented in tables 2 and 3, respectively. In addition to the cash contributions earmarked for individual programmes, the tables show in the column "EOA-GEN" the non-earmarked cash contributions for the effects-oriented activities; in the column "CIAM" the contributions allocated to the Centre for Integrated Assessment Modelling; in the column "T. contr." the total contributions from individual countries to the Trust Fund for the year; in the column "PYC" the past years' contributions during the year; and in the column "Recom. contr." the recommended contributions from individual countries to the Trust Fund for the year.

8. The voluntary contributions in kind towards partially financing the essential coordination of effects-oriented activities paid to the Trust Fund in 2005 and in 2006 (as of 31 May 2006) are presented in tables 4.a and 4.b, respectively.

9. In addition to the voluntary contributions in cash and in kind shown in tables 2, 3 and 4, and to the substantial contributions made by the lead countries of the programmes and by the countries hosting the programme centres directly to the centres, a number of Parties provided additional support to effects-oriented activities by hosting task force meetings, workshops and/or expert meetings.

II. USE OF VOLUNTARY CASH CONTRIBUTIONS IN 2006

10. The use of earmarked and non-earmarked cash contributions in 2000–2006 (as of 31 May 2006) is presented in table 5. The non-earmarked cash contributions to the Trust Fund enabled significant amounts, compared to previous years, to be used in 2005 for supporting the activities not covered by the EMEP Protocol. The line "Substantive reporting" represents (a) funds provided in 2001 to the programmes as partial compensation for the expenses that they had previously incurred while preparing the report "Trends in the impacts of long-range transboundary air pollution"; and (b) funds provided in 2002, 2003 and 2004 to cover the costs of a consultant hired to prepare and help finalize the 2004 substantive report on the review and assessment of air pollution effects and their recorded trends.

11. Before Executive Body decision 2002/1, voluntary cash contributions were paid to Programme Centres rather irregularly and payments were dependent on the availability of funds. Since 2002, contributions have become sufficiently regular to allow regular, annual payments. Implementing Instruments are currently used in the formal contracting procedure used by the United Nations for this Trust Fund. A similar process is used for the EMEP Centres.

12. Formal contracts with Implementing Instruments have been used to distribute voluntary cash contributions in 2006. These were drawn up between UNECE and the institutes recognized in Executive Body decision 2002/1 as being nominated as programme (coordinating) centres for the International Cooperative Programmes (ICPs) and the Task Force on the Health Aspects of Air Pollution. The Bureau of the Working Group approved the tasks and outputs for the centres as listed in the Convention's 2006 workplan.

III. DEVELOPING THE FUNDING MECHANISM FOR CORE ACTIVITIES

13. At its twenty-third session, the Executive Body requested the Working Group on Effects in collaboration with the secretariat to consider how to improve the information on budgeting,

financing and workplan completion. The programme centres have drawn up their budgets in advance for approval, but contributions from Parties, which are unpredictable in their amount and time of payment, have only partly matched the budgets. No plans (e.g. pledging payments in advance) have been proposed to justify more detailed budgeting. The secretariat has during the past few years provided the financial information in various formats to satisfy the needs of the Working Group and the Executive Body. It also has received financial statements from the centres on the Trust Fund contribution expenditure. The Working Group has made significant progress in disseminating the results, which are reported separately for each workplan item in the annual joint report of the Working Group.

14. The Executive Body also requested the secretariat to provide information on in-kind contributions by Parties in support of core activities not falling under decision 2002/1 and requested Parties to provide the secretariat with the necessary information for this. The secretariat has dealt with declarations to record in-kind contributions, which vary in amount and nature. The information is made available in table 4.

15. The Executive Body further noted the need for the Working Group on Effects to discuss possibilities for the distribution of trust fund support. The secretariat has continued to share the non-earmarked contributions equally between all programme centres due to the lack of information on the needs of the programme centres and the undeclared in-kind contributions of Parties to them. A review mechanism would only be possible if payment were suspended to allow accumulation of funds before a workplan was agreed.

IV. PRIORITY TASKS FOR 2007 (TO BE PARTLY FINANCED BY THE TRUST FUND)

16. At its meeting in Geneva from 1 to 3 March 2006, the Extended Bureau of the Working Group on Effects, comprising the Bureau of the Working Group, the Chairs of the Task Forces and the representatives of the programme centres of ICPs, agreed that the formal contracts continue to be based on the adopted workplan of the Convention. The draft 2007 workplan for the Working Group on Effects and the proposed lists of tasks for each programme can be found in document ECE/EB.AIR/WG.1/2006/4.
