COMPLIANCE BY TURKMENISTAN WITH ITS OBLIGATIONS UNDER THE CONVENTION*

The Meeting of the Parties,

Acting under paragraph 37 of the annex to decision I/7 on the review of compliance,

^{*} This document was submitted on the above date to allow the Bureau to take into account the report of the Compliance Committee on compliance by Turkmenistan (ECE/MP.PP/2008/5/Add.8), which had been circulated for consultations with the Parties concerned.

Mindful of the conclusions and recommendations set out in its decision II/5c with regard to compliance by Turkmenistan (ECE/MP.PP/2005/2/Add.9),

Recalling the regret expressed by it in decision II/5c with regard to the lack of response from the Party concerned in the course of compliance review pursuant to the requirements set out in the annex to decision I/7,

Taking note of the report of the Compliance Committee (ECE/MP.PP/2008/5) and its addendum 8 (ECE/MP.PP/2008/5/Add.8),

- 1. *Notes with regret* the failure of the Government of Turkmenistan to take measures to implement decision II/5c of the Meeting of the Parties;
- 2. *Also notes* the initial engagement of the Government of Turkmenistan demonstrated by its correspondence with the Committee and the participation of its representatives in a meeting of the Committee;
- 3. *Confirms* its earlier endorsement of the Committee's findings with regard to compliance by Turkmenistan as set out in paragraph 1 of decision II/5c;
- 4. *Decides*, in the light of continuing failure by Turkmenistan to take any meaningful measures to implement decision II/5c, to issue a caution to the Government of Turkmenistan;
- 5. Reiterates its request to the Government of Turkmenistan to implement specific targeted measures to bring its legislation and practice into compliance with the provisions of the Convention as set out in paragraph 2 of decision II/5c;
- 6. *Invites* the Government of Turkmenistan to submit to the Committee periodically (in November 2008, November 2009 and November 2010) detailed information on further progress in implementing the measures referred to in paragraph 5;
- 7. Also invites the Government of Turkmenistan to consider accommodating an expert mission, with the involvement of Committee members and other experts, as appropriate, with a view to making available to it a wide range of expert opinion on possible ways to implement the measures referred to in decision II/5c, including any possible amendments to the Act on Public Associations.
- 8. *Requests* the secretariat and the Compliance Committee, and invites relevant international and regional organizations and financial institutions, to provide advice and assistance to the Party concerned, as necessary, in the implementation of these measures.
 - 9. *Undertakes* to review the situation at its fourth meeting.
