

## II. Proposed organization of the sessions: overview<sup>1</sup>

Two bodies will meet in conjunction in a single meeting room within a sessional period from 20 to 23 June 2011:

- (a) The Meeting of the Parties to the Convention (MOP), for its fifth session;
- (b) The Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol (MOP/MOP), for its first session.

Delegates will be invited to be present throughout the sessional period.

The Chair of the Bureau of the Meeting of the Parties to the Convention will open the fifth session of the MOP. The MOP will take up items 1 and 2 of the provisional agenda. The opening meeting will then be adjourned.

The first session of the MOP/MOP will then be opened. The MOP/MOP will take up items 1 and 2 of its provisional agenda. The opening meeting will then be adjourned.

The MOP and the MOP/MOP will convene in joint and individual meetings, in sequence, until the high-level segment is convened.

The high-level segment will open on the morning of Thursday, 23 June, and continue until 6 p.m. The MOP and the MOP/MOP will convene in joint and individual meetings, in sequence, including for the adoption of decisions and a declaration. Ministers and other heads of delegation will be invited to deliver statements to a joint meeting of the MOP and the MOP/MOP.

# III. Annotations to the provisional agenda

## **General segment**

#### 1. Opening of the session

Tentative timing: Monday, 20 June, afternoon

Strategic Environmental Assessment)

The Meeting will be opened by the Chair of the Bureau, Mr. A. Vesic, Assistant Minister, Ministry of Environment and Spatial Planning, Serbia.

The Chair of the Bureau will invite the Meeting to adopt decision I/1 on the adoption of the rules of procedure.

As the fifth session of the Meeting of the Parties to the Convention (MOP5) and the first session of the Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol (MOP/MOP1) will be held during the same sessional period, this overview addresses both meetings. For ease of reference for Parties and observers, the text of this overview is also contained in the annotated provisional agenda for MOP5 (ECE/MP.EIA/14).

#### 2. Organizational matters

Tentative timing: Monday, 20 June, afternoon

# (a) Election of the Chair of the Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol for the general segment

The Meeting will be invited to elect its Chair for the general segment.

#### (b) Adoption of the agenda

Documentation: ECE/MP.EIA/SEA/1 (Annotated provisional agenda for the first

session)

ECE/MP.EIA/SEA/2011/INF.1 (Informal notes on the agenda)

The secretariat, in agreement with the Chair of the Bureau, has drafted the provisional agenda for the session contained in the present document, taking into account views expressed by the Parties during the third session of the Meeting of the Signatories to the Protocol and after consulting the Bureau. The Parties will be invited to adopt the agenda.

#### (c) Report on credentials

According to rule 16 of the rules of procedure of the MOP (ECE/MP.EIA/2, decision I/1), which will apply, mutatis mutandis, to the MOP/MOP following its adoption of its decision I/1, the credentials of representatives of Parties, as well as the names of alternate representatives and advisers, shall be submitted to the secretariat if possible not later than 24 hours after the opening of the session. Any later change in the composition of the delegation shall also be submitted to the secretariat. The credentials shall be issued either by the Head of State or Government or by the Minister of Foreign Affairs or, in the case of a regional economic integration organization, by the competent authority of that organization. The Bureau will examine the credentials and report on them to the Meeting (see rule 17 of the rules of procedure). Representatives shall be entitled to participate provisionally in the session, pending a decision by the Meeting to accept their credentials (see rule 18 of the rules of procedure). Only Parties with valid credentials will be able to participate in the adoption of a decision or declaration.

The Meeting will be invited to take note of the report on credentials of the representatives of Parties attending the first session of the Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol. Representatives may participate provisionally, pending this action.

#### (d) Status of the Protocol

The secretariat will inform the Meeting about the status of ratification of the Protocol and the declarations made by Parties upon deposit of their instruments of ratification of the Protocol.

#### 3. Outstanding issues

#### (a) Draft declaration

Delegations will be invited to comment on the draft declaration under consideration by the Meeting.

The MOP and the MOP/MOP will then convene in a joint meeting and are expected to discuss and agree on the outstanding issues set out below prior to the high-level segment.

#### (b) Draft decision on the adoption of the workplan

The Chair of the Bureau will present revised draft decision I/9 on the adoption of the workplan, amended by the Bureau in response to the comments made at the third session of the Meeting of the Signatories to the Protocol and at the fourteenth meeting of the Working Group on Environmental Impact Assessment. The secretariat will present an informal assessment of the degree to which the workplan adopted at the fourth session of the Meeting of the Parties has been completed. The Meeting is expected to review the draft decision in detail, ensuring that for each sub-activity full information is provided on the organizational arrangements, expected outcome, time schedule and budget. The Meeting is expected to discuss and finalize draft decision I/9.

#### (c) Draft decision on the budget, financial arrangements and financial assistance

The Chair of the Bureau will present revised draft decision I/10 on the budget, financial arrangements and financial assistance, amended by the Bureau in response to the comments made at the third session of the Meeting of the Signatories to the Protocol and at the fourteenth meeting of the Working Group. The secretariat will present its report on the budget and financial arrangements in the period since the fourth session of the Meeting of the Parties.

Delegations will then be invited to pledge contributions to the budget.

The Meeting is expected to finalize the text of the draft decision I/10 in the light of this information and of its earlier deliberations under item (b) above.

# (d) Accession by Member States of the United Nations not members of the Economic Commission for Europe

The secretariat will report on interest in acceding to the Protocol expressed by any Member State of the United Nations not member of the Economic Commission for Europe. For any such State the Meeting will need to consider the adoption of a decision approving accession.

#### (e) Other draft decisions

Delegations will be invited to comment on other draft decisions under consideration by the Meeting.

# (f) Nomination of officers and tentative calendar of meetings for the next intersessional period

The Chair for the general segment will invite delegations to nominate a chair and a number of vice-chairs of the Bureau. He or she will suggest that the Bureau include the chair and three vice-chairs of the working group that is expected to be established later in the sessional period. In addition, the general segment Chair will propose that the chair and one vice-chair of the Implementation Committee — once elected by the Committee and in accordance with the expected decision on the application of the compliance procedure of the Convention to the Protocol — be members of the Bureau. Further, he or she will suggest that the chair of the future working group be a representative of a State or a regional economic integration organization that is a Party to both the Convention and the Protocol.

Following each nomination, the Chair will ask the secretariat to inform the MOP and the MOP/MOP of whether the State nominated is a Party to the Convention or the Protocol. Once sufficient nominations have been made, the Chair will invite the MOP and the MOP/MOP to consider the endorsement of the nominations in turn. Formal election of the Bureau members will take place later in the sessional period (item 9), once a decision has been taken on the establishment of a subsidiary body.

The above procedure will be repeated for the new members of the Implementation Committee.

The Meeting may agree a tentative calendar of meetings of its subsidiary bodies in the intersessional period. Delegations may also wish to put forward proposals for hosting such meetings.

#### 4. Review of work done by the Meeting of the Signatories

Tentative timing: Wednesday, 22 June, morning

The Meeting is expected to review the work done by the Meeting of the Signatories to the Protocol and by Parties pending the entry into force of the Protocol.

#### (a) Institutional and procedural activities

The Bureau will report on the completion of the institutional and procedural activities assigned to it by the Meeting of the Parties to the Convention at its sessions held in 2003,

2004 and 2008, and by the Meeting of the Signatories to the Protocol during its three sessions.

#### (b) Other activities relating to the Protocol listed in the workplan

Delegations will be invited to report on workshops and other events promoting ratification and application of the Protocol. The secretariat will report on the resource manual to support application of the Protocol.

# **High-level segment**

### 5. Opening ceremony for the high-level segment

Tentative timing: Thursday, 23 June, morning

# (a) Election of the Chair of the Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol at its first session for the high-level segment

The MOP and the MOP/MOP will convene in a joint meeting and will be invited to elect their Chair for the high-level segment.

#### (b) Introductory speeches

The high-level segment will begin with a keynote speech by a senior official from Switzerland. The Executive Secretary of the Economic Commission for Europe will make an opening statement.

#### 6. Statements by Ministers and high-level representatives

Tentative timing: Thursday, 23 June, morning

Statements by delegates will be heard in a joint meeting of the MOP and the MOP/MOP.

Ministers and other heads of delegation, as well as representatives of intergovernmental organizations and non-governmental organizations, may make statements, with a recommended time limit of three minutes. The full texts of the official statements will be circulated if sufficient numbers of copies are provided to the secretariat in the course of the session. Delegations are requested to register statements in advance of the session.

#### 7. Adoption of decisions

Tentative timing: Thursday, 23 June, morning

The Chair will introduce each decision to the Meeting, indicating its title and number, the symbol of the document containing the draft text for consideration and an indication of which States are invited to consider and adopt the decision: States Parties to the Convention; States Parties to the Protocol; or States Parties to either instrument. Members of the Bureau will provide additional information on each decision, as appropriate. The decisions will be introduced in the sequence indicated below.

#### 9. Election of officers for the next intersessional period

The MOP and the MOP/MOP will convene in a joint meeting and will be invited to elect officers for the next intersessional period, following the earlier agreement on nominations (item 3 (f) above).

The Meeting will consider the election of States nominated as a Party to both instruments, i.e., the Parties to either instrument will be invited to consider the nomination.

The Meeting will consider the election of States nominated as a Party to the Convention, i.e., only Parties to the Convention will be invited to consider the nomination.

The Meeting will consider the election of States nominated as a Party to the Protocol, i.e., only Parties to the Protocol will be invited to consider the nomination.

The above procedure will be repeated for the new members of the Implementation Committee.

The Chair will invite the Meeting to express its gratitude to the outgoing members of the Bureau.

#### 10. Date and venue of next meetings

Tentative timing: Thursday, 23 June, afternoon

The MOP and the MOP/MOP will convene in a joint meeting and will be expected, in accordance with rule 4 of the rules of procedure, to decide on the date and venue of the sixth session of the MOP to be held in conjunction with the second session of the MOP/MOP.

#### 12. Conclusion of the session
