PROGRAMME AREA 2

PREVENTION AND REDUCTION OF WATER-RELATED DISEASES



STRENGTHENING WATER-RELATED DISEASE SURVEILLANCE, OUTBREAK DETECTION AND MANAGEMENT

- Support and capacity building on **implementation of Articles 8**: provisions of guidance documents
- Assist in **improving outbreak surveillance**, emergency preparedness, alert and response operations
- Strengthen capacities to respond to emergencies through the establishment of a **roster of experts**
- Develop **training package** and conduct regional/subregional **trainings**
- Update and maintain the **Atlas on Water and Health**



PROMOTING TARGETED HEALTH INTERVENTIONS FOR WATER- AND SANITATION-RELATED DISEASES

○ Rotavirus infections:

- Most important single cause of infant death in the world
- Support advocacy and awareness-raising activities on cost-effective health interventions
- Promote use of rotavirus vaccines in national immunization programmes as a part of a comprehensive strategy to control diarrhoeal diseases

○ Soil transmitted helminth infections:

- Support country efforts to prevent and control intestinal helminth infections in conjunction with promoting access to safe water, sanitation and hygiene



SUPPORT COST-EFFECTIVE DRINKING-WATER QUALITY SURVEILLANCE

- Develop cost-effective and risk-based drinking-water quality **surveillance approaches**
- Develop criteria for **identifying and prioritizing** drinking-water quality parameters:
 - Decision-support tool
 - Fact sheets for laboratory analysis of priority parameters
- Special consideration for **rural areas** (see program area 3): linked to update of WHO Guidelines
- Regional and subregional **capacity building**



STRENGTHEN HYGIENE EDUCATION AND PROMOTE SANITATION IN SCHOOLS

- Review, adapt and disseminate available **awareness-raising** materials
- Implement **pilot projects** on sanitation in schools (jointly with programme areas 3 and 4)
- Apply **school surveys** through the ENHIS platform
- Mainstream with implementation of the **Parma Declaration** Regional Priority Goal 1



WORK APPROACH

- Activities to be carried out by thematic **expert groups** (no Task Force)
- **Lead Parties** for individual themes
- **Cooperation** with program areas 1, 3 and 4
- **Estimated cost:** 760,700 USD



PROGRAMME AREA 3

SMALL SCALE WATER SUPPLIES AND SANITATION



Development of policy and guidance document

- Finalization of the policy guidance document in English and Russian (and national languages)
- Promotion of the policy guidance document and support of implementation through sub-regional capacity-building workshops: determine needs for concrete actions to improve the situation of SSWSS with national stakeholders



Improvement of evidence base, field projects

- Rapid assessments of prevailing setting of small-scale water supply systems (including condition of systems, water quality, sanitary risks, incidence of diarrhoeal disease) at national level
- Water and sanitation safety plans: pilot projects for management of small scale water supply and sanitation systems
- Link to programme area 4 (safe and efficient management of water supply and sanitation systems)
- E.g. WOP together with UN-Habitat



Information sharing and regional networking

- WHO-hosted Small Community Water Supply Management (SCWSM) network
 - Facilitate access
 - Host a meeting in the region
- Establish internet platform for sharing experience, tools available and case studies



PROGRAMME AREA 4

SAFE AND EFFICIENT MANAGEMENT OF WATER SUPPLY AND SANITATION SYSTEMS



CAPACITY-BUILDING ON WATER AND SANITATION SAFETY PLANS

- Organise **capacity-building workshops** at national and regional levels on water and sanitation safety plans
 - Sensitize national decision makers and strengthen of national legislation
 - Particular consideration on small systems (program area 3), schools (program area 1) and hospitals
- **[Piloting and scaling-up]**



EXCHANGE OF EXPERIENCE ON SAFE AND EFFICIENT MANAGEMENT OF WATER SUPPLIES AND SANITATION SYSTEMS

- Organise **capacity-building workshops** at national and regional levels on water and sanitation safety plans
 - Sensitize national decision makers and strengthen of national legislation
 - Particular consideration on small systems (program area 3), schools (program area 1) and hospitals
- **[Piloting and scaling-up]**
- **Kick off event on safe and efficient management**
incl. performance, safety and effectiveness of WS&S systems
(reduction water losses, incl. low costs technologies)



WORK APPROACH

- **Lead Parties** need to be identified
- **Cooperation** with program areas 1 and 3
- **Estimated costs:** 372,500USD

AWARENESS RAISING

→ Show challenges faced & need to adopt equity-oriented governance framework

ASSESSING EQUITY OF ACCESS TO WATER AND SANITATION

→ Development of coordinated baseline analysis on equity at national and local level

DEVELOPING ACTION PLANS FOR EQUITABLE ACCESS

→ Define priority action plans according to country context

Lead: France and other Party to be determined

Estimated costs: 706,000 USD
