

II. Annotations

- 1. At its fourth session (Geneva, 14-16 November 2016), the Meeting of the Parties to the Protocol on Water and Health to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) highlighted the role of the Protocol as a powerful tool to promote and operationalize the achievement of the 2030 Agenda for Sustainable Development (2030 Agenda) and its Sustainable Development Goals (see ECE/MP.WH/13–EUPCR/1611921/2.1/2016/MOP-4/06, forthcoming). The main objectives of the tenth meeting of the Working Group on Water and Health under the Protocol are therefore to take stock of the progress in the implementation of the water, sanitation and health-related Sustainable Development Goals in the pan-European region and to discuss how to benefit from the Protocol's practical framework to facilitate their achievement. The Working Group will also review the implementation of the programme of work for the period 2017-2019 (ECE/MP.WH/13/Add.1–EUPCR/1611921/2.1/2016/MOP-4/06/Add.1, forthcoming) and provide guidance on its further development, while giving particular consideration to the financial situation.
- 2. The meeting will begin on Wednesday, 15 November 2017, at 10 a.m. and will close on Thursday, 16 November 2017, at 5.30 p.m. It will be held back to back with the fifteenth

meeting of the Protocol's Compliance Committee (Geneva, 13-14 November 2017) and the nineteenth meeting of the Bureau (Geneva, 17 November 2017).

- 3. The working languages of the meeting will be English, French and Russian.
- 4. All relevant documentation for the meeting of the Working Group will be available online on the United Nations Economic Commission for Europe (ECE) website.¹

3. Role of the Protocol in achieving the 2030 Agenda for Sustainable Development

7. The Working Group will discuss how to benefit from and give prominence to the work under the Protocol with regard to the implementation, follow-up and review of the Sustainable Development Goals, in particular with a view to the 2018 meeting of the high-level political forum on sustainable development, which will conduct an in-depth review of Goal 6 on clean water and sanitation. The Working Group will discuss the experiences of countries in the implementation of water, sanitation and health-related Sustainable Development Goal targets, in particular the experience of countries that will undergo Voluntary National Reviews at the high-level political forum in 2018, and possible contributions to the 2018 Regional Forum on Sustainable Development for the ECE region.

4. Progress in the ratification process

8. As of 31 August 2017, the following 26 countries are Parties to the Protocol on Water and Health: Albania, Azerbaijan, Belarus, Belgium, Bosnia and Herzegovina, Croatia, Czechia, Estonia, Finland, France, Germany, Hungary, Latvia, Lithuania, Luxembourg, Netherlands, Norway, Portugal, Republic of Moldova, Romania, Russian Federation, Serbia, Slovakia, Spain, Switzerland and Ukraine. There have been no changes in membership since the third session of the Meeting of the Parties to the Protocol (Oslo, 25-27 November 2013).

9. Representatives of signatories and other States not yet Party to the Protocol will be invited to report on any recent or anticipated developments in their respective countries with respect to becoming a Party to the Protocol.

5. Improving governance for water and health: support for setting targets and implementing measures

Tentative timing: Wednesday, 15 November, 11.50 a.m.-1 p.m. and 3-3.30 p.m.

(a) Setting targets and implementing measures

- 10. The Chair of the Task Force on Target Setting and Reporting will report on the outcomes of the 3dorkshop on setting targets under the Protocol to support implementation of the Sustainable Development Goals (Geneva, 4-5 May 2017) and on the ninth meeting of the Task Force (Geneva, 5 May 2017).
- 11. Countries in which substantial progress with regard to target-setting processes has been achieved since the ninth meeting of the Task Force will be invited to report on any significant developments.
- 12. The Chair will report on progress in preparing the guidance document on how to translate the 2030 Agenda into national targets set under the Protocol. The Working Group will be invited to discuss the draft outline of the document and agree on the next steps for its preparation and publication.
- 13. The Working Group will be informed about the national and subregional workshops conducted or planned in order to support the setting of targets, the implementation of measures and public participation in the Protocol's implementation.

(b) Strengthening reporting capacity

- 14. The Working Group will be updated on developments in the global framework for monitoring the achievement of the Sustainable Development Goals with regard to indicators pertinent to water, sanitation and health, in particular in terms of the data-gathering exercise to establish the baseline for Goal 6 indicators. The Working Group will exchange experience in monitoring and reporting on water, sanitation and health-related Sustainable Development Goal indicators and will discuss how the work under the Protocol could support future efforts, including the implications for the reporting system under the Protocol.
- 15. The Working Group will be informed about the key messages of the WHO/United Nations Children's Fund (UNICEF) Joint Monitoring Programme for Water Supply and Sanitation 2017 progress report and Sustainable Development Goal 6 baseline report on drinking water, sanitation and hygiene. The Working Group will also be presented the outcomes of the fourth reporting cycle of the UN-Water Global Analysis and Assessment of Sanitation and Drinking Water (GLAAS), in particular the main findings of the 2017 report, Financing Universal Water, Sanitation and Hygiene under the Sustainable Development Goals, and the highlights for the participating countries.

Representatives of Belarus and Norway, lead Parties for programme area 2.1 of the 2017-2019 work programme on strengthening capacity in surveillance of water-related diseases and outbreak management, will inform the Working Group about the progress of work. The update will address in particular the outcomes of the national workshop on water-related disease surveillance carried out in Kyrgyzstan (Bishkek, 23-25 May 2017) and the organization of a meeting of the lead Parties to define the priority activities and steps towards implementation (Bonn, Germany, 3 November 2017).
- 18. Participants will be invited to provide information on activities to strengthen waterrelated disease surveillance and outbreak response systems in accordance with article 8 of the Protocol on Water and Health.

19. Representatives of the lead Parties will inform the Working Group about the planned activities in this programme area for the period 2017-2019. The Working Group will discuss the proposed activities.

- 22. Representatives of Belarus and Norway will inform the Working Group about the planned activities in this programme area for the period 2017-2019. The Working Group will discuss the proposed activities.

- 24. The Working Group will be informed about the outcomes of the side event on WASH in schools organized at the high-level conference on "Promoting intersectoral and interagency action for health and well-being in the WHO European Region" (Paris, 7-8 December 2016), in particular initiating new networks and partnerships.
- 25. Participants will be invited to provide information on national activities on WASH in schools, including setting and implementing targets under the Protocol.
- 26. Representatives of Georgia, Hungary and Republic of Moldova will inform the Working Group about the planned activities in this programme area for the period 2017-2019. The Working Group will discuss the proposed activities.

(b) Water, sanitation and hygiene in health-care facilities

- 27. The Working Group will be informed about the progress of work on water, sanitation and hygiene in health-care facilities. In particular, the WHO Regional Office for Europe secretariat will present preliminary results of an evidence review undertaken for the WHO European Region, preliminary results of a model assessment on WASH in health-care facilities carried out in Kazakhstan and the main outcomes of and strategic recommendations from the regional meeting on improving WASH health-care facilities (Bonn, Germany, 27-28 September 2017).
- 28. The Working Group will be invited to provide feedback on the draft report on the situation of WASH in health-care facilities in the WHO European Region and agree on the next steps towards its finalization.
- 29. Participants will be invited to provide information on national activities on WASH in health-care facilities, including setting and implementing targets under the Protocol.

The Working Group will provide comments, as needed, on the work accomplished and will discuss future activities in this area.
- 45. The Working Group will hear details of the side event, "Water, sanitation, hygiene and health: closing the equity gap", organized during the Sixth Ministerial Conference on Environment and Health (Ostrava, Czechia, 13-15 June 2017) to highlight evidence and

promote tools developed under the Protocol for ensuring equitable access to WASH services for all.
