RATIFICATION STATUS OF THE WATER CONVENTION, ITS AMENDMENTS AND PROTOCOLS

Note by the secretariat

I. INTRODUCTION

- 1. The present document sets out the ratification status of the 1992 Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention), the amendments to its articles 25 and 26, as well as its Protocols.
- 2. As of 23 May 2018, 41 countries and the European Union were Parties to the Water Convention. Chad acceded to the Convention as first African country on 22 February 2018.
- 3. As of 23 May 2018, 41 countries and the European Union had ratified or accepted the amendments to articles 25 and 26 of the Convention, adopted in 2003. The amendments entered into force on 6 February 2013 and became operational on 1 March 2016.
- 4. The 1999 Protocol on Water and Health to the Water Convention was signed by 36 countries and ratified, acceded, accepted or approved by 26 Parties, as of 23 May 2018. The Protocol entered into force on 4 August 2005.
- 5. The Protocol on Civil Liability and Compensation for Damage Caused by the Transboundary Effects of Industrial Accidents on Transboundary Waters to the Water Convention and to the 1992 Convention on the Transboundary Effects of Industrial Accidents was signed in Kiev in 2003 and has not yet entered into force. As of 23 May 2018, 24 countries signed the Protocol and one country (Hungary) had ratified it (not listed overleaf).
- 6. The 1997 United Nations Convention on the Non-Navigational Uses of International Watercourses (UN Watercourses Convention) has 36 Parties, as of 23 May 2018. The Convention entered into force on 17 August 2014.
