On the Position of Ukraine Regarding Consideration of Draft Decision V/4 by the Fifth Session of the Meeting of the Parties to the Espoo Convention. 20-23 June 2011, Geneva

On the proposal of the Implementation Committee, Decision V/4 of the Fifth session of the Meeting is dedicated to the review of compliance.

In particular, it deals with the issue of the implementation of the project on the Deep Navigable Route in the Ukrainian sector of the Danube Delta (so called "Danube-Black Sea Water Navigation Canal"), as the follow-up to Decision IV/2 regarding Ukraine.

Upon the recommendations contained in Decision IV/2 of the Meeting of the Parties to the Espoo Convention, Ukraine has undertaken sizeable efforts in order to meet those recommendations and to implement its obligations under the Convention.

Given below is the comparative table of actions taken by Ukraine in order to fulfill the abovementioned recommendations, which is self-explanatory.

The Government of Ukraine has been supported by the EU project on the implementation of the Espoo Convention in Ukraine.

12. "Also requests the Government of Ukraine to submit to the Implementation Committee by the end of 2009 a strategy, taking into account the efforts by the Government of Ukraine to implement the provisions of the Convention and based on the outcome of the independent review, including its time schedule and training and other actions to bring about compliance with the Convention, and thereafter to report to the Committee on the implementation of the strategy".

In December 2009 the Government of Ukraine has submitted to the Implementation Committee "Strategy on the Implementation of Provisions of Espoo Convention by the Government of Ukraine worked out to implement Para. 11-12 of Decision IV/2".

This Strategy, in particular, took into account the output of the independent review mentioned in item 12 of the Decision.

14. "Invites the Government of Ukraine to enter into negotiations with its neighboring Parties to cooperate in the elaboration of bilateral agreements or other arrangements in order to support further the provisions of the Convention, as set out in Article 8, and to seek advice from the secretariat. The Government of Ukraine is invited to report on progress with the elaboration of such agreements, particularly with Romania, to the Implementation Committee by the end of 2010 and to the fifth meeting of the Parties".

The Ministry of Environment of Ukraine has prepared and sent out the invitations to six neighboring countries with the purpose to enter into the negotiations to cooperate in the elaboration of bilateral agreements in order to support further the provisions of the Convention, as set out in Article 8.

The Ukrainian side sent letters dated 12.11.2010 to the Belarusian side and dated 07.12.2010 to Moldova, Poland, Slovakia, Hungary, Romania with the draft of bilateral agreement in accordance with Article 8 of the Espoo Convention.

In particular, the negotiations with Belarus, Poland and Slovakia have been accomplished. The agreement has been reached with Romania to hold such negotiations during May 2011 in Kyiv.

As could be seen from this table, the recommendations of the Meeting of the Parties have been duly fulfilled by relevant actions of Ukraine, which were implemented in full scope. Information on these actions was reported by Ukraine to the respective sides and bodies.

With the adoption by Ukraine of the Final Decision on 25 January 2010, the issue of implementation of the project on the Deep Navigable Route in the Ukrainian sector of the Danube Delta has been put in full compliance with the provisions of the Convention. In the spirit of transparency and sincere cooperation, Ukraine has demonstrated its unreserved commitment to the principles and provisions of the Convention and its sincere desire to unblock the stalemate over this controversial issue in the region of Danube.

We hope to enjoy the support of this position by the Parties to the convention at their Fifth session of the Meeting of the Parties due next June in Geneva.
