Since 2013, the UNECE within the EaP GREEN framework has been supporting Ukraine in developing the national SEA and EIA system.

On March 20, 2018 the Verkhovna Rada of Ukraine adopted the Law of Ukraine "On strategic environmental assessment". Currently, the signing of the Law on SEA by the President of Ukraine is expected. The objective of the final event is to:

- Introduction to the international obligations of Ukraine for the implementation of strategic environmental assessment;
- Discussion features the introduction of strategic environmental assessment of the legal system of Ukraine

The event is organized by the Ministry of Ecology and Natural Resources of Ukraine in cooperation with the United Nations Economic Commission for Europe (UNECE) within the framework of the EaP GREEN.
