II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Item 1. Adoption of the agenda

The Committee will be invited to adopt the agenda as set out in the present document, also taking into account any points raised for consideration by representatives of non-governmental organizations present at the meeting as observers.

Item 2. Relevant developments since the previous meeting of the Committee

The Committee will be invited to share any information on relevant developments since its previous meeting that is not covered under other agenda items.

Item 3. Matters arising from previous meetings

The Committee will be invited to discuss any matters arising from its previous meetings that are not covered under other agenda items.

Item 4. Submissions by Parties concerning other Parties

The Committee is expected to consider, in accordance with the relevant procedures, any submissions made by Parties concerning another Party's compliance with its obligations under

the Convention, as provided for under paragraph 15 of the annex to decision I/7 of the Meeting of the Parties.

Item 5. Submissions by Parties concerning their own compliance

The Committee is expected to consider, in accordance with the relevant procedures, any submissions made by Parties concerning their own compliance with the obligations under the Convention, as provided for under paragraph 16 of the annex to decision I/7.

Item 6. Referrals by the secretariat

The Committee is expected to consider, in accordance with the relevant procedures, any referrals made by the secretariat concerning possible non-compliance by individual Parties with their obligations under the Convention, as provided for under paragraph 17 of the annex to decision I/7.

Item 7. Communications from members of the public

The Committee is mandated to consider, in accordance with the relevant procedures, communications from the public, as provided for under chapter VI of the annex to decision I/7.

- (a) The Committee is expected to decide whether to conclude its consideration of communication ACCC/C/2005/15 (Romania), taking into account the provisional conclusion reached at its previous meeting (ECE/MP.PP/C.1/2009/2, para. 10) and subsequent comments provided thereon by the Party concerned and the communicant.
- (b) The Committee is expected to take note of correspondence received from the communicant with respect to communication ACCC/C/2007/21 (European Community) since its twenty-third meeting and consider whether any further action is required.
- (c) The Committee is expected to finalize and adopt its findings and, as appropriate, recommendations with regard to communication ACCC/C/2007/22 (France), taking into account comments received from the Party concerned and the communicant.
- (d) The Committee is expected to discuss the content of communications ACCC/C/2008/23 (United Kingdom), ACCC/C/2008/27 (United Kingdom), ACCC/C/2008/29 (Poland) and ACCC/C/2008/30 (Republic of Moldova). In accordance with paragraph 32 of chapter IX of the annex to decision I/7, the Parties concerned and the communicants are entitled to participate in the discussion on the subject matter of the respective communications, though not in the preparation or adoption of any findings, measures or recommendations of the Committee.
- (e) The Committee is expected to continue its deliberations on communications ACCC/C/2008/24 (Spain) and ACCC/C/2008/26 (Austria) in closed session with a

view to completing its preparation of draft findings and, if appropriate, recommendations.

(f) The Committee is expected to discuss how to proceed with communication ACCC/C/2008/28 (Denmark), including the possible timing of a discussion on the substance of the case.

(g) The Committee is expected to consider any new information received with regard to communications ACCC/C/2008/31 (Germany), ACCC/C/2008/32 (European Community), ACCC/C/2008/33 (United Kingdom), ACCC/C/2008/35 (Georgia), ACCC/C/2009/36 (Spain) and ACCC/C/2009/37 (Belarus).

(h) The Committee will discuss any new communications received sufficiently in advance of the meeting, in particular with respect to their admissibility and any issues that may need to be raised with the Party concerned.

(i) The Committee may discuss any other issues related to communications.

Item 8. Reporting requirements

The Committee is expected to consider, in the light of its mandate under paragraph 13 (c) of the annex to decision I/7, matters related to the implementation of decision III/5 on reporting requirements and the procedures for the preparation by Parties of their implementation reports for the fourth meeting of the Parties.

Item 9. Matters arising from the Meeting of the Parties, including follow-up on specific cases of non-compliance

The Committee will be invited to discuss any progress with regard to implementation of decisions III/6, III/6a, III/6b, III/6c, III/6d and III/6f. The Committee will in particular consider any findings by the secretariat about synergies between the Aarhus and the Espoo Convention to strengthen Armenia's legislative framework with respect to environmental impact assessment as required by decision III/6b. The Committee will also consider any information received from the Government of Lithuania with regard to implementation of decision III/6d.
