## **II. Annotations**

### **1. Adoption of the agenda**

The Compliance Committee under the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) will be invited to adopt its agenda as set out in the present document, taking into account any points raised for consideration by representatives of non-governmental organizations present at the meeting as observers.

### **2. Introduction of and solemn declaration by new Committee members**

New members of the Committee will be invited to introduce themselves and will make a solemn declaration that they will perform their functions impartially and conscientiously (ECE/MP.PP/2/Add.8, annex, para. 11).

### **3. Election of officers**

The Committee will confirm the election of its Chair according to the electronic decision-making procedure, and will then be invited to elect its Vice-Chair (ECE/MP.PP/2/Add.8, annex, para. 9).

### **4. Relevant developments since the previous meeting of the Committee**

The Committee will be invited to share any information on relevant developments since its previous meeting that are not covered under other agenda items.

### **5. Matters arising from previous meetings**

The Committee will be invited to discuss any other matters arising from its previous meetings that are not covered under other agenda items.

## **6. Submissions by Parties concerning other Parties**

In accordance with the relevant procedures, the Committee is expected to consider any submission made by a Party concerning another Party's compliance with its obligations under the Aarhus Convention, as provided for under paragraph 15 of the annex to decision I/7 of the Meeting of the Parties (ECE/MP.PP/2/Add.8).

## **7. Submissions by Parties concerning their own compliance**

In accordance with the relevant procedures, the Committee is expected to consider any submission made by a Party concerning its own compliance with the obligations under the Convention, as provided for under decision I/7, annex, paragraph 16.

## **8. Referrals by the secretariat**

The Committee is expected to consider, in accordance with the relevant procedures, any referrals made by the secretariat concerning possible non-compliance by individual Parties with their obligations under the Convention, as provided for under decision I/7, annex, paragraph 17.

## **9. Communications from members of the public**

In accordance with the relevant procedures, the Committee is mandated to consider communications from the public, as provided for under decision I/7, annex, chapter VI. In this context:

(a) The Committee is expected to finalize and adopt its findings and, as appropriate, recommendations with regard to communication ACCC/C/2010/48 (Austria) in closed session, taking into account comments received from the Party concerned and the communicant;

(b) The Committee is expected to continue its deliberations on communication ACCC/C/2010/50 (Czech Republic) in closed session with a view to completing its preparation of draft findings and, if appropriate, recommendations;

(c) The Committee is expected to discuss the substance of communications ACCC/C/2010/51 (Romania), ACCC/C/2010/54 (European Union) and ACCC/C/2011/57 (Denmark). In accordance with decision I/7, annex, paragraph 32, the Parties concerned and the communicants are entitled to participate in the discussion on the subject matter of the communication;

(d) The Committee is expected to consider any new information received with regard to communications ACCC/C/2008/28 (Denmark), ACCC/C/2008/31 (Germany), ACCC/C/2010/45 (United Kingdom of Great Britain and Northern Ireland), ACCC/C/2010/53 (United Kingdom), ACCC/C/2010/55 (United Kingdom), ACCC/C/2011/58 (Bulgaria), ACCC/C/2011/59 (Kazakhstan) and ACCC/C/2011/60 (United Kingdom);

(e) The Committee will discuss any new communications received sufficiently in advance of the meeting, in particular with respect to their admissibility and any issues that may need to be raised with the Party concerned or the communicant.

**10. Matters arising from the decisions of the Meeting of the Parties, including follow-up on specific cases of non-compliance**

The Committee will be invited to discuss any progress with regard to implementation of decisions IV/9 and IV/9a-i of the Meeting of the Parties.

**11. Programme of work and calendar of meetings**

The Committee is expected to discuss and decide upon its programme of work and to identify dates for its future meetings.

**12. Other business**

At present the secretariat has no other business to suggest under this agenda item.

**13. Adoption of the report**

The Committee will be invited to adopt the report of the meeting.
