## **II. ANNOTATIONS TO THE PROVISIONAL AGENDA**

### **Item 1. Adoption of the agenda**

The Committee will be invited to adopt the agenda as set out in the present document, also taking into account any points raised for consideration by representatives of non-governmental organizations present at the meeting as observers.

### **Item 2. Relevant developments since the previous meeting of the Committee**

The Committee will be invited to share any information on relevant developments since its previous meeting that is not covered under other agenda items.

### **Item 3. Matters arising from previous meetings**

The Committee will be invited to discuss any matters arising from its previous meetings that are not covered under other agenda items.

### **Item 4. Submissions by Parties concerning other Parties**

The Committee is expected to consider, in accordance with the relevant procedures, any submissions made by Parties concerning another Party's compliance with its obligations under the Convention, as provided for under paragraph 15 of the annex to decision I/7 of the Meeting of the Parties.

**Item 5. Submissions by Parties concerning their own compliance**

The Committee is expected to consider, in accordance with the relevant procedures, any submissions made by Parties concerning their own compliance with the obligations under the Convention, as provided for under paragraph 16 of the annex to decision I/7.

**Item 6. Referrals by the secretariat**

The Committee is expected to consider, in accordance with the relevant procedures, any referrals made by the secretariat concerning possible non-compliance by individual Parties with their obligations under the Convention, as provided for under paragraph 17 of the annex to decision I/7.

**Item 7. Communications from members of the public**

The Committee is mandated to consider, in accordance with the relevant procedures, communications from the public, as provided for under chapter VI of the annex to decision I/7.

- (a) The Committee is expected to finalize and adopt its findings and, as appropriate, recommendations with regard to communications ACCC/C/2008/26 (Austria), ACCC/C/2008/29 (Poland) and ACCC/C/2008/30 (Republic of Moldova), taking into account comments received from the Parties concerned and the communicants.
- (b) The Committee is expected to continue its deliberations on communications ACCC/C/2008/23 (United Kingdom), ACCC/C/2008/24 (Spain) and ACCC/C/2008/27 (United Kingdom) in closed sessions with a view to completing its preparation of draft findings and, if appropriate, recommendations.
- (c) The Committee is expected to discuss the substance of some aspects of communication ACCC/C/2008/32 (European Community), notably those related to the judgment of the European Court of Justice in the WWF-UK v. Council of the European Communities case (C-355/08). In accordance with paragraph 32 of chapter IX of the annex to decision I/7, the Party concerned and the communicant are entitled to participate in the discussion on the subject matter of the communication.
- (d) The Committee is expected to discuss the substance of communication ACCC/C/2008/33 (United Kingdom). In accordance with paragraph 32 of chapter IX of the annex to decision I/7, the Party concerned and the communicant are entitled to participate in the discussion on the subject matter of the communication.
- (e) The Committee is expected to consider any new information received with regard to communication ACCC/C/2008/28 (Denmark) and to discuss how to proceed, having regard to paragraph 21 of the annex to decision I/7.

(f) The Committee is expected to consider any new information received with regard to communications ACCC/C/2008/35 (Georgia), ACCC/C/2009/36 (Spain) and ACCC/C/2009/37 (Belarus).

(g) The Committee is also expected to consider any new information received with regard to communications ACCC/C/2009/38 (United Kingdom), ACCC/C/2009/40 (United Kingdom) and ACCC/C/2009/41 (Slovakia), and discuss how to proceed with these communications, including the possible timing of discussions on the substance of the cases.

(h) The Committee is expected to make a preliminary determination on the admissibility of communication ACCC/C/2009/39 (Austria), taking into account any further information provided by the communicant.

(i) The Committee will discuss any new communications received sufficiently in advance of the meeting, in particular with respect to their admissibility and any issues that may need to be raised with the Party concerned or the communicant.

(j) The Committee may discuss any other issues related to communications.

#### **Item 8. Reporting requirements**

The Committee is expected to consider, in the light of its mandate under paragraph 13 (c) of the annex to decision I/7, matters related to the implementation of decision III/5 on reporting requirements and the procedures for the preparation by Parties of their implementation reports for the fourth meeting of the Parties.

#### **Item 9. Matters arising from the Meeting of the Parties, including follow-up on specific cases of non-compliance**

The Committee will be invited to discuss any progress with regard to implementation of decisions III/6, III/6a, III/6b, III/6c, III/6d, III/6e and III/6f. The Committee will in particular consider any information received from the Government of Lithuania with regard to implementation of decision III/6d.
