Statement of the State Secretary of the Ministry of Environment of the Slovak Republic to the Budva Declaration (Item 4)

Honourable ministers, Excellencies, Ladies and Gentlemen, dear Aarhus friends,

I am very delighted to address you today from the beautiful city of Budva and I would like to convey the very best greetings from the Government of the Slovak Republic to the government and people of Montenegro.

I am also honored and privileged to participate in this historical event during which the Budva Declaration will be adopted and I would like to thank the Aarhus Secretariat and the Government of Montenegro for their tremendous effort and in preparing this event.

Slovakia highly appreciates the work and activities carried out over last years in the field of Aarhus Convention and its Protocol on PRTRs and we share the same principles.

public awareness campaigns as well.

In order to meet future Aarhus Convention 's challenges we definitely need to enhance and

strengthen cooperation at a regional and international level while promoting environmental

democracy and well-being. With adoption of the Budva Declaration we symbolically open door

for better and sustainable future
