II. Annotations

The Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) was adopted in Aarhus, Denmark, on 25 June 1998. In celebration of the twentieth anniversary of the adoption of the Convention, the twenty-second meeting of the Working Group of the Parties to the Convention will feature a special segment to celebrate past achievements and to look forward, in particular to consider how to engage with youth in creating a sustainable future. Former and present chairs of different bodies of the Aarhus Convention, representatives of Governments, non-governmental organizations and other stakeholders will be invited to share their testimonies. The segment will take place on Wednesday, 20 June.

A networking event will be held during the special segment at lunchtime with the aim of matching countries' capacity-building needs with available expertise in other countries and partner organizations. The event will be held in three breakout groups focusing on different themes based on the capacity-building needs identified. During the event, participants will have the opportunity to move between the various group discussions.

Furthermore, two thematic sessions, on access to information (on 19 June) and on the promotion of the principles of the Convention in international forums (on 21 June), will be held to discuss these subjects in greater detail.

General segment

1. Opening of the meeting and adoption of the agenda

Timing: Tuesday, 19 June, 10–10.15 a.m.

The Chair of the Working Group will make an introductory statement. The Working Group will thereafter be invited to adopt the agenda for its twenty-second meeting as set out in the present document.¹

2. Status of ratification of the Convention and the amendment to the Convention

Timing: Tuesday, 19 June, 10.15–10.30 a.m.

The secretariat will provide the Working Group with an overview of the status of ratification, acceptance, approval and accession with respect to the Aarhus Convention and the amendment to the Convention. Delegations will be invited to report on any recent or anticipated developments concerning ratification, acceptance, approval or accession with respect to these instruments. The Working Group is expected to take note of these developments.

3. Substantive issues

(a) Thematic session on access to information

Timing: Tuesday, 19 June, 10.30 a.m.–1 p.m.

A thematic session on access to information will be organized in the format of an interactive panel discussion followed by a general discussion on the basis of several selected questions. The topics for discussion will include a number of subjects based on: (a) decision VI/1 on promoting effective access to information (see ECE/MP.PP/2017/2/Add.1) adopted by the Meeting of the Parties at its sixth session (Budva, Montenegro, 11–13 September 2017); (b) the key outcomes of the work of the Task Force on Access to Information; and (c) issues of a systemic nature addressed through the work of the Compliance Committee. The topics for discussion include: (a) the benefits of providing public access to environmental information and the challenges encountered; (b) the scope of environmental information; (c) the providers of information; (d) exceptions to the provision of information and grounds for refusal; (e) the format of the information to be provided and timeliness; and (f) dissemination of real-time, up-to-date, accurate and functional environmental information in forms and formats meeting the needs of different users. The session will involve youth, Governments and representatives of international and non-governmental organizations and other stakeholders.

Timing: Thursday, 21 June, 9.30 a.m.–12.30 p.m.

A thematic session on the promotion of the principles of the Convention in international forums will be organized in the format of panel presentations and round-table discussions. The session will focus primarily on the promotion of public participation in international decision-making on chemicals and waste. Additional topics will include an update on stakeholder engagement at the twenty-third session of the Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC) and preparations for the twenty-fourth session of the Conference of the Parties; the access to information and stakeholder engagement policies of the United Nations Environment Assembly and the United Nations Environment Programme; the high-level political forum on sustainable development and Sustainable Development Goals-related processes; international financial institutions processes; and cross-cutting issues related to international decision-making (e.g., hosting of an international event or identification of the public).
