Introduction

A thematic session on access to justice aims to promote implementation of article 9 of the Aarhus Convention and to draw on recent developments and trends in this area. Its outcomes are expected to support implementation of other important commitments, notably, the achievement of Sustainable Development Goals, in particular Goal 16 with its target 16.3.

The thematic session will be organized in a format of a panel followed by a general discussion. Discussion will be focused on a number of subjects based on decision VI/3 on promoting effective access to justice (see ECE/MP.PP/2017/2/Add.1) adopted by the Meeting of the Parties at its sixth session (Budva, Montenegro, 11–13 September 2017) and the key outcomes of the work of the Task Force on Access to Justice².

The session will consider the role of public interest litigation (e.g. in challenging refusals of information requests, acts or omissions that contravene permit requirements or laws relating to the environment) which is expected to be addressed through different presentations and will provide an opportunity to discuss the achievements and barriers in relation to the following key issues: standing; scope of review; assistance mechanisms and costs; timeliness; remedies; protection against harassment and other forms of retaliation. The Working Group of the Parties will also consider synergies with relevant activities under other international forums. Further, the session will touch upon the issue of cooperation between ministries of the environment and ministries of justice.
