# Written statements to 24th meeting of the Aarhus Convention Working Group of the Parties (1-3 July 2020, virtual)

Respectable partners, ladies and gentlemen's,

Regarding the topic of this session, public participation in decision-making, I would like to inform you that in North Macedonia we still encounter disrespect for access to information and non-participation of the public in decision-making processes. Namely, after the struggle of the local population from the eastern part of the country against the mining license of Ilovica, the government last July terminated the contract for obtaining a mining license at the Ilovica mine. The company sued and the second-instance commission for deciding in administrative proceedings rejected the appeal of the company "Euromax Resources" filed after the Government's decision in July last year to reject the request for exploitation of metallic mineral resources in the concession area of Ograzden Mountain.

Now, the Administrative court made a decision allowing the company to continue operating the Ilovica mine during a **state of emergency when the courts were closed**. The decision was made, but activists and citizens found out about it from Canadian websites. It was only after the reaction of the activists and the government, which by the way claims that she was not familiar with the decision of the administrative court, that they announced the Decision ...

What should we do when decisions are made during a state of emergency and when citizens are forced to be locked up at home? This is one of example of non-implementation of the Aarhus Convention!

### **Privacy Policy**

Journalists Human Rights - JHR has adopted a Privacy Policy. In that direction, the data, such as name, surname, postal address, contact telephone number and e-mail address, are collected and used only for the needs of the projects. Personal data will be stored in a form that allows the identification of the subject of personal data, no longer than it is necessary to meet the purposes for which the data is collected for further processing, after which it is deleted and destroyed.

JHR will not publish, sell or make available to third parties your personal data except to the competent state authorities in a manner and to a certain extent determined by the positive legal regulations of the Republic of Macedonia.

The NCP also considers the privacy and confidentiality of personal information important and respects the privacy of visitors to its websites at all times.

In accordance with the Data Protection Act, we have updated the privacy policy for visitors to our websites.

#### Note for persons under 18 years of age

NCP employees take care to protect the privacy of persons under the age of 18. If you are under the age of 18, ask your parent / guardian for permission before sharing your personal information with us.

Updated privacy rules from May 2018

#### a) AUTOMATIC INFORMATION FROM YOU

The NCP website uses cookies and collects information about IP addresses, downloaded content, number of visitors, time visits and visits to demographic data by country, all for statistical purposes. The NCP does not disclose the information collected in this way to third parties under any circumstances, except in the case of a legal obligation.

In addition to these statistics, these websites do not collect data on visitors, except for information voluntarily from visitors and in the normal course of communication with the NCP. All personal data that visitors discover during the communication remains strictly confidential and their processing is in accordance with the Law on General Data Protection.

The email addresses you provide to us are used solely to send newsletters or notifications via the mailing list, which is usually sent on a monthly basis.

We store your email addresses in the database which is also located on the monthly information generation page. The NCP has taken all necessary security measures to ensure the use of your data only for the purposes for which we have been given consent.

Collecting information through a cookie serves to optimize your user experience and track general site traffic statistics and traffic analysis via Google Analytics (a service that provides anonymous page tracking).

The NCP occasionally conducts questionnaires on the effects of its programs, opinion polls and the like. These questionnaires are conducted electronically or in writing. Individual goals and data usage are part of the data collection form. Please send us questions regarding individual research at detstvo@detstvo.org.mk

#### C) WHO HAS BEFORE YOUR DATA?

Your data is stored in a protected database that is stored on the NCP servers and can only be accessed by a person working in the NCP and is authorized to access the data, as well as for purposes for which there is user consent (for example, for which you have given explicit permission) or legal basis for use. NCP employees are bound by the Rules of Procedure and the Data Protection Policy, which is harmonized with the Law on Personal Data Protection.
