Key challenges for joint bodies

- Mechanisms of institutional arrangements (plenipotentiaries and commissions): advantages, disadvantages and specifics of the organisational structure
- Scope of cooperation (bilateral, multilateral/basin wide, from single-purpose to multipurpose) and consequences on composition and national inter-agency coordination
- Legal, administrative and financing aspects (rules of procedure and other regulations, financing of the joint bodies)
- Coordination functions (collection, processing and exchange of data and information, research and studies, formulation and harmonization of policies and regulations, training)
- Executive functions and enforcement (joint monitoring and assessment of the resources, checking compliance with provisions of the existing agreements, development and execution of regulations such as water apportionment schedules and pollution prevention rules, management of international projects, early warning systems for emergency situations (floods, drought, pollution accidents))
- Environmental impact assessment and dispute settlement
- Public participation and Stakeholder/NGO Forums mechanisms and impact on decision making process
- Cooperation with other joint bodies and in particular regional seas commissions
- From informal to formal cooperation

It is expected that the development of the background paper will yield important themes for discussion. Tasks will be given beforehand to participants to make short prepared statements/interventions. Rapporteurs are nominated for each of four geographic areas Caucasus (Zurab Jincharadze, Georgia), Central Asia (Gulnar Daniyarova, Kazakhstan), Eastern Europe-EU¹ (Mikhail Kalinin, Belarus), Eastern Europe²(Victor Buzhak, Moldova), with the task to extract conclusions for each of the four geographic areas.
