International water law, current status and evolution of the Conventions, introduction to substantive and procedural norms *Alistair Rieu Clarke*, *Northumbria University*

Discussions in groups for 20 minutes to elaborate the differences and similarities in terms of physical scope, substantive principles, procedure, legal and institutional arrangements (global and basin level), dispute settlement mechanism. Each group gets assigned to a question, but is free to look at other questions as well.
