





REGIONAL WORKSHOP ON LINKAGES WITH OTHER EXISTING MONITORING AND REPORTING MECHANISMS RELATED TO WATER AND HEALTH

Geneva, 3 July 2014

Palais des Nations, Room VIII, starting at 10:00 a.m.

I. BACKGROUND

At its third session in November 2013, the Meeting of the Parties to the Protocol on Water and Health mandated the Task Force on Target Setting and Reporting to implement a number of activities to improve the quality of reporting at the regional level, in particular by supporting the establishment of linkages with other monitoring and reporting mechanisms.

The review of national summary reports submitted by Parties and other countries during the second reporting exercise¹ in 2013 indeed indicated that the countries participate in a number of other monitoring and reporting mechanisms related to water and health. They specifically referred to the frameworks provided by the EU Directives (Water Framework Directive, Drinking Water Directive and Groundwater Directive) for reporting about the quality of the drinking water supplies or the effectiveness of management, protection and use of freshwater resources, and the World Health Organization (WHO) / United Nations Children's Fund (UNICEF) Joint Monitoring Programme for Water Supply and Sanitation (JMP) for reporting about access to drinking water and sanitation.

II. OBJECTIVES OF THE REGIONAL WORKSHOP

The regional workshop aims to (i) support the establishment of linkages between the reporting mechanism under the Protocol on Water and Health and other existing regional and global monitoring programmes such as the WHO/UNICEF JMP, the UN-Water Global Analysis and Assessment of Sanitation and Drinking-Water (GLAAS) and the European Environment and Health Information System (ENHIS); (ii) discuss possible ways to link target setting and reporting under the Protocol with existing national monitoring and information systems; (iii) inform about proposed post-2015 development goals and indicators on water and sanitation and discuss the possible ways to integrate these into the national target setting process.

The regional workshop will provide a platform for interactive discussion on possible synergies related to data sources, data processing and reporting, by focusing on the following questions:

- How can data gathered through existing national and international monitoring mechanisms on water, sanitation and health help countries in setting a baseline situation and defining priority targets under the Protocol?
- In what extent and what indicators could Parties use from the data produced under existing reporting mechanisms in preparing the national summary reports?
- What is the added value of the Atlas on Water and Health to the target setting process and how could it support reporting under the Protocol?
- How can the reporting under the Protocol be linked with global monitoring efforts (for example potential linkage with the post-2015 monitoring of water, sanitation and health)?

The outcomes of the discussions should provide guidance for defining a strategic vision for future reporting under the Protocol on Water and Health. The suggestions and proposals from the workshop will be discussed during the seventh meeting of the Task Force on Target Setting and Reporting (4 July 2014) and be considered for a possible revision of the *Guidelines on Target Setting and Reporting*.²
