INTERNATIONAL MIGRATION'S DATA SOURCES IN CZECH REPUBLIC

Submitted by the Czech Statistical Office

Statistics on migration flows.

- 1. The Czech Statistical Office receives notifications of migration. A database file was established summarising individual notifications. This file covers variables like:
 - birth-number
 - firstname, surname
 - sex
 - date of birth
 - country of birth
 - family status
 - educational status
 - citizenship
 - reason of migration (work, school, health, family reunification, marriage, divorce)
 - former address (in case of international migration only the country of previous residence)
 - new address (in case of international migration only the country of next residence)
 - date of event
- 2. The file covers two major subsets of migration: internal migration (permanent residence change from one municipality to the other) and international migration (crossing the borderline movement)
- 3. This old migration file covered:
 - foreigners, who got the permanent residence permission, regardless the previous length of stay in Czech Republic, were covered as 'immigrants' to the Czech Republic
 - in above mentioned category were also Czech citizens who came back from abroad to the Czech Republic
 - foreigners with permanent residence permit leaving the Czech Republic and mentioning this fact
 to Immigration Police; and Czech citizens who told to registration office of residence, that they
 leave the Czech Republic on a permanent base are covered as 'emigrants' from the Czech
 republic.
 - Czech citizens and foreigners, who changed their permanent residence in the Czech Republic (both addresses are in CR) made 'internal migration'
- 4. From 2001 on, there are many changes in international and internal migration statistics following to the 1998 UN Recommendations.

- 5. According to the fact, that it is impossible to differ a-priori the group of long-term migrants (UN Recommendations) it was necessary to redefine former group of 'immigrants' for foreigners with visa over 90 days which length of stay at first exceeds 1 year. The new Foreigners Stay Act unfortunately does not provide for covering the one year length of stay. The following represents the only possible approximation, because it is not possible to keep two sets of files and outputs (preliminary and definitive)
- 6. Foreigners are registered as international immigrants after passing one year of stay; at the moment when they change their usual residence in the Czech Republic. They are registered as emigrants, when leaving the Czech Republic for longer time (the end of the residence permit, deregistration, repatriation, etc.). Data on foreigners-international immigrants, foreigners-international emigrants and foreigners who acquired the Czech citizenship are being sent to the Czech Statistical Office through automatically generated export batch from district offices of the Immigration Police . Internal migration of foreigners is also registered by the Immigration Police, but in a paper form. Immigration Police does not consider migration between the two municipalities within one district as a significant change (thus does not generate an electronic record). However, this is considered as an important change by the Czech Statistical Office (for the population balance to the level of municipalities).
- 7. Migration of Czech citizens is registered in an old way -- using the "permanent residence" concept.

Statistics on Foreigners in the Czech Republic - Stock data.

- 8. Till the end of 2000 Czech Statistical Office did not have any separate inhabitant's balance by citizenship There was only the balance of inhabitants. It covered Czech citizens and foreigners with permanent residence in the Czech republic but without any breakdown by citizenship. Any available information about the stock data of long-term resident foreigners came from the database of foreigners operated by Immigration Police.
- 9. The following variables are stored in the database (covering either long-term or permanently resident foreigners):
 - personal identification number;
 - all names;
 - sex;
 - date of birth;
 - type of the residential permit (asylum, visa under 90 days; visa over 90 days; permanent residence);
 - purpose of residence;
 - the beginning of the residence in the Czech Republic;
 - the end of validity of the residential permit;
 - ISO- Alpha-3 code of the state of citizenship (published by the UN Statistics Division in ST/ESA/STAT/SER.M/49/Rev.4);
 - nationality;
 - country of birth;
 - country of previous residence;
 - address of the residence in the Czech Republic;
 - name, address and identification number (business register) of the employer;
 - selected spouse's data;
 - number of children.

- 10. The data are available from the Immigration Police. Possibilities of providing the stock data to Czech Statistical Office are being discussed. Data from the Immigration Police will have to be completed with the identification number (business register) of the employer. This would permit a linkage with the business register of the Czech Statistical Office's Register, in order to obtain data according to the International Classification of All Economic Activities (ISIC Rev. 3 / NACE, Rev. 1).
- 11. Presently, data on economic activity of foreigners are obtained from the register of the Ministry of Industry and Trade and from databases of local labour offices. Unfortunately, there is no centralised register of work permits for foreigners.
- 12. Czech Statistical Office will start balancing the population by citizenship with the base stock according to the 2001 round of Population Census (rebalanced to 1st of January 2001).

Problems with the 1998 UN Recommendations on Statistics of International Migration.

- 13. A basic problem is represented by the fact, that this area isn't solved by any new EU regulation. It is not necessary to reproduce the content of the UN Recommendations in the Regulation. It is impossible due to different approaches among countries and to the fact, that immigration policy is an integral part of policy system of each state. However, some basic principles of the Recommendations should be regularised officially and be obligatory (for example the definitions in Box 1 and Table 1 of Recommendations) One year time point isn't regularised in the Czech Foreigners' Stay Act. If there is no EU regulation on this, there is no chance to make the Ministry of Interior and the Immigration Police to support relevant changes in the law. Probably, in majority of the EU countries, NSIs have better position in the legislation process, but the Czech Statistical Office is not in a position to initiate a change of the law only on a basis of the UN Recommendations.
- 14. Another problem is not so good cooperation of the Czech citizens, particularly in the area of emigration. There is a legal obligation to announce the to go abroad for long time (1 year and over) to the Registration Office. This is often neglected, because there are no sanctions specified in the legislation. This (together with the difference to the past definitions only a "permanent residence" change to abroad) is the reason for substantial discrepancies between data on emigration provided by the Czech Republic and immigration provided by the other countries. Probably, it is not a specific problem only for the Czech Republic.
- 15. In the context of this problem, we would like to ask, how the problem of free movement among the EU countries is solved by EU member states?
- 16. One more problem is related to the separate evidence of the international civil servants. A possible solution is to assign dummy business identification numbers of the international organisations (as employers of international civil servants), and to distinguish these numbers from the other ones in database.
- 17. The Czech Statistical Office is positioned low in the hierarchy of the national civil service. The right to obtain data from administrative sources is legally based on the Statistical Service Act. However, provision of administrative data for statistical purposes has not become a common practise in majority of areas (e.g. tax and, income, driving licences, vehicle registration, etc.). The data do exist, but the Czech Statistical Office does not have an easy access to the data maintained by other parts of civil service.
