**Summary of national experiences with the implementation of the 1997 UN Recommendations on
International Migration Statistics**

Prepared by the ECE Secretariat

1. The participants at the last joint ECE-Eurostat-ESCWA joint meeting on migration statistics (Geneva, 8-10 May 2000) discussed the possibilities of implementation of the 1997 UN Recommendations on the basis of reports prepared by a small number of countries that had participated in a Task Force, which was established to look into issues associated with the implementation of the new set of UN Recommendations (a summary of these reports was issued as CES/SEM.42/2/Add.1 and Add.2). They agreed that it would be useful if other countries would prepare a similar type of report for the 2001 ECE-Eurostat meeting on migration statistics.
2. In November 2000 the ECE Secretariat sent a letter to ECE countries requesting them to prepare reports as suggested at the May 2000 meeting on migration statistics. Twenty-one countries replied and provided the requested information. These responses are summarised in Tables 1-3 of this note, together with relevant information from papers prepared for the May 2000 Meeting, and it covers 25 countries. The list of countries included in this summary is provided in Table 4.
3. Participants are encouraged to consult addenda 1-21 to Working Paper No. 2 for additional and more detailed information on how the countries responded to the circular letter..

Structure of the tables

4. The summary consists of three tables – migration inflow, migration outflow and stock of migrants. For each category required according to the UN Recommendations, ISO codes for countries that can supply data for the category concerned are indicated. These three tables correspond to the questionnaire prepared by the Task Force for the May 2000 meeting.
5. In its circular letter the ECE Secretariat suggested to the national statistical offices that the document that the United Kingdom prepared for the May 2000 meeting (CES//SEM.42/16) should be used as a standard pattern for responding. Most countries followed the suggested structure and pattern. However, a few countries used another structure in their report, and for these countries the ECE Secretariat transformed their information into the standard pattern.

Quality assessment

6. Ordinarily if a country code is included in a table cell, a good data quality was reported (or implied). The utilisation of symbols “*” and “**” next to the country code indicates data of medium or low quality, for the category of migration concerned. This quality assessment is based on the information provided by countries. Countries themselves indicated the data quality. For other countries, the ECE Secretariat used the text of country reports to indicate the quality (for example, if countries indicated that the coverage was not full with respect to all migrants or with respect to the access to the historical data). This is the case mainly for the migration stock data.

Possible follow-up

7. Participants at the meeting are invited to correct the overview tables where necessary and to finalise the summary by incorporating comments or notes in them. Other countries, not specifically mentioned in the tables, may be added, where possible.

8. Participants at the meeting are also invited to identify and suggest possible ways of encouraging a larger number of countries in the ECE region and elsewhere to comply with the 1997 UN Recommendations on International Migration Statistics.
