INFORMATION NOTICE TO PARTICIPANTS

Regional Meeting on Revision of Economic Classifications to be held at the Palais des Nations, Geneva starting on 29 September 2004 at 10:00

I. PURPOSE OF THE MEETING

1. The purpose of the Meeting is to inform the countries from the ECE region about the ongoing revision of the International Standard Industrial Classification (ISIC) and the Central Product Classification (CPC). It also aims at getting countries' comments and feedback on the detailed drafts of ISIC Rev.4 that was prepared by the UNSD and sent to the statistical offices.

II. PROVISIONAL AGENDA OF THE MEETING

2. The meeting will focus on the following substantive topics:

- Presentation and discussion of ISIC Rev.4 draft;
- Discussion of CPC ver.2 revision and proposals;
- Discussion of ISCO revision.

3. Details on the provisional agenda, the authors of invited and supporting papers, and the provisional timetable for the meeting will be presented at the UNECE web site.

Countries are invited to present their experience with the implementation of activity and product classifications, requirements for national applications of the classification and resulting proposals for the international standard classifications. Discussion of the draft ISIC Rev.4 classification is encouraged in that context.

Any contributions to the meeting should be sent by e-mail to Ms. Tihomira Dimova at the address: <u>tihomira.dimova@unece.org.</u> The contributions should be in Word format and be a maximum of ten pages (including tables, references, etc.). They should reach the ECE Secretariat by 5 July 2004. Any last minute documentation submitted by participants will be circulated in the in the meeting room but will not be translated and formatted.

8. Participants are requested to bring copies of the documents mentioned in the provisional agenda to the meeting. There will be only a limited amount of documentation available in the meeting room.

IV. PARTICIPATION AND LANGUAGES

9. In accordance with standard UNECE practice, national statistical offices in the UNECE region are invited to send their experts. Furthermore, OECD member states and other United Nations member states are also invited to participate. Also a number of international organizations, e.g. Eurostat, the OECD, the ILO and CIS-Stat are invited.

10. The working languages of the meeting will be English and Russian. Simultaneous interpretation will be provided.

V. ALLOWANCES, ACCOMMODATION, PASSPORT AND VISA REGULATIONS

11. Participants are expected to pay for their own travel and per diem. They are requested to make their own hotel reservations. Therefore, participants are requested to present themselves at the **Security Identification Section, located at the Villa Les Feuillantines, 13 Avenue de la Paix (see attached map)**, in order to be issued with an identification badge. Participants are advised to present themselves at the Security Section at least 40 minutes before the beginning of the meeting. Delegates are also requested to keep the ID card with them at all times for the duration of the meeting. 18. There are two gates that can be used by participants for entering the UN premises: the pedestrian passage at Place des Nations (buses 5 and 8 from the central station Cornavin, stop Nations) and the Pregny Gate (Avenue de la Paix 14, buses 8 and 18, stop Appia). 


