The meeting of the OECD Statistics Committee will take place back-to-back with the CES plenary session.

II. Annotations

The sixty-fourth plenary session of the Conference of European Statisticians will convene at the request of the sixty-third CES plenary session (ECE/CES/89) and in accordance with the *Rules Governing the Work of the Conference and its Bureau* (CES/2005/2).

1. Opening addresses and adoption of the agenda

The final provisional agenda and timetable was agreed upon by the CES Bureau at its 9-10 February 2016 meeting. The provisional agenda will be presented for the approval of the Conference.

2. Matters arising from the 47th session of the United Nations Statistical Commission – *for information*

The agenda item will focus on the implications of the decisions of the United Nations Statistical Commission (UNSC) on the work of CES.

3. Strategic partnerships – *for discussion and recommendations*

This part of the CES plenary session will be organized in a format of a seminar, chaired by Canada. The discussion will consider partnerships of national statistical offices with other organisations in the information industry. The challenges of increasing data needs, e.g. through the upcoming reporting on Sustainable Development Goals (SDGs) combined with technological advances and data revolution make it ever more important for statistical offices to find new partnerships and new ways of providing data and services. The discussion will focus on mutually beneficial relationships with members of the information industry that are formed to enable and further develop innovation in official statistics.

(a) Topic 1: Building beneficial partnerships

The main basis for the session will be a paper by the United Kingdom, prepared in collaboration with Austria, Mexico, Turkey and Eurostat. The session will share examples of beneficial partnerships between a national statistical office and other actors in the information industry.

(b) Topic 2: Panel discussion on the way forward

The session will be organized as an interactive panel discussion. The focus will be on the discussion of strategic choices and the way forward for statisticians. The session is expected to conclude with recommendations to national statistical offices and their potential partners on how to engage in effective partnerships.

4. Work of the High-level Group for the Modernisation of Official Statistics – *for decision*

The High-level Group for the Modernisation of Official Statistics (HLG-MOS) was set up to guide strategic developments in the ways official statistics are produced. The Conference has expressed strong support for the work, endorsed the vision and the strategy for modernizing official statistics, and decided that the HLG-MOS should present annual reports to the CES plenary session.

The HLG will submit its annual report on implementing its strategy to the Conference for approval. The Conference will be invited to discuss the outcomes of recent projects in the area of statistical modernisation and priorities for the work in 2016. **The content of this item is subject to the outcome of the discussions of the CES Bureau in February 2016.**

5. How to implement the monitoring system for the Sustainable Development Goals – *for discussion and recommendations*

The aim of the discussion will be to obtain input from the CES members to the road map on developing official statistics for monitoring SDGs under CES. The discussion will be organized by the secretariat in collaboration with the CES Steering Group on monitoring SDGs. The Task Force on adjusting the CES framework to measure sustainable development to SDGs will present the preliminary results of its work.

The content of this item is subject to the outcome of the discussions of the CES Bureau in February 2016.

6. Geospatial information services based on official statistics – for discussion and recommendations

This part of the CES plenary session will be organized in a format of a seminar, chaired by Austria. Numerous policy initiatives, e.g. on climate change and disaster preparedness, stress the benefits of linking environmental and socioeconomic data to location attributes. In addition to improving the quality of the unit level spatial referencing, statistical offices would need to significantly improve access to spatial statistical information and develop ways of sharing data to more effectively serve policy needs. Development may have been held back by data confidentiality and privacy concerns, but also due to lack of common tools and approaches.

The seminar will discuss the challenges arising from international and global drivers such as the Global Geospatial Information Management (UN–GGIM), INSPIRE (in Europe) and the SDGs. The seminar will consider the way forward to develop an international spatial reference framework, define a conceptual framework for the integration of geospatial and statistical data, and achieve cooperation between national statistical offices and mapping agencies. The discussion will also consider current experiences at national and international levels, and share information on latest methodological developments.

The session is expected to conclude with some recommendations for follow-up work under CES.

7. Reports, guidelines and recommendations prepared under the umbrella of the Conference

Three final documents will be submitted to the 2016 CES plenary session for endorsement and one interim report for discussion and recommendations.

(a) Measuring human capital – for decision

The *Recommendations on Measuring Human Capital* were prepared by a Task Force, set up by the CES in June 2013. The objective was to pursue the conceptual development of human capital measurement, with priority given to developing experimental human capital satellite accounts. The Bureau reviewed the progress of work in January 2014, and provided advice on drafting the final recommendations.

The CES Bureau reviewed the draft Recommendations at its February 2016 meeting, and decided that they can be sent for an electronic consultation to all CES members before the CES plenary session. Subject to the positive outcome of the consultation, the Guidelines will be submitted to the 2016 CES plenary session for endorsement.

(b) Circular migration – for decision

The *Guidelines on Circular Migration* were developed by a Task Force, set up by the CES Bureau in February 2013. The purpose of the Task Force was to assess current user needs, methodology and available data sources to measure circular migration; examine the impact of using different definitions for circular migration; and propose a common international statistical definition of circular migration.

The CES Bureau reviewed the draft Guidelines at its February 2016 meeting, and decided that they can be sent for an electronic consultation to all CES members before

the CES plenary session. Subject to the positive outcome of the consultation, the Guidelines will be submitted to the 2016 CES plenary session for endorsement.

(c) Ageing-related statistics – for decision

The *Recommendations on ageing-related statistics* were developed by a Task Force, set up by the CES Bureau in February 2013. The objective of the Task Force was to develop recommendations for improving the availability, accessibility and comparability of statistical data in support of ageing-related policymaking. The Task Force involved statisticians, policymakers and academia providing a good example of efficient cooperation between different stakeholders.

In October 2015, the CES Bureau decided that the *Recommendations on ageing-related statistics* can be sent for electronic consultation to all CES members. The document will be circulated for comments in early 2016. Subject to the positive outcome of the consultation, the document will be submitted to the Conference for endorsement.

(d) Value of official statistics, interim report – for discussion and recommendations

As a follow-up to the CES 2014 seminar “What is the value of official statistics and how do we communicate that value?”, the CES Bureau established a Task Force on value of official statistics in February 2015. The objective of the Task Force is to define the value of official statistics and develop ways for its measurement that will allow for better understanding and communication of this value to society.

The CES Bureau discussed the interim report at its February 2016 meeting, and provided advice on further work. The interim report will be submitted to the CES plenary session for further discussion and recommendations.

8. Technical cooperation: Generic Statistical Law developed as part of a United Nations Development Account (UNDA) 9th tranche project – for discussion and endorsement

UNECE developed, jointly with Eurostat and EFTA, a Generic Statistical Law as part of a broader UNECE statistical capacity building project financed through the United Nations Development Account¹. The work is being done in support of further development of the legal and institutional frameworks for official statistics, based on recommendations and findings of Global Assessments of national statistical systems conducted in the countries of Eastern Europe, Caucasus and Central Asia.

The Generic Statistical Law will be submitted to the 2016 CES plenary session for discussion and endorsement.

9. Coordination of international statistical work in the United Nations Economic Commission for Europe region – for decision

This agenda item concerns the decisions that the Conference is expected to take regarding the coordination of international statistical work in the UNECE region.

The Conference will be informed about the outcomes of in-depth reviews of selected statistical areas carried out by the CES Bureau. These reviews are important tools of

coordination to identify gaps or duplication of work and address emerging issues. The reviews focus on strategic issues and highlight concerns of statistical offices of both a conceptual and a coordinating nature.

The Conference will consider short reports on the outcomes of the in-depth reviews carried out by the CES Bureau since the previous CES plenary session in June 2015. The in-depth reviews of 'Strategic partnerships' and 'Geo-spatial information services based on official statistics' served as input to the CES seminars, and will be considered under agenda items 3 and 6.

The Conference will be invited to endorse the outcome of the in-depth review of 'Diversification of population census methodology and sources' conducted by the CES Bureau in October 2015.

10. Programme of work of the United Nations Economic Commission for Europe (UNECE) Statistics subprogramme

(a) Reports on the work of the Conference of European Statisticians, its Bureau and Teams of Specialists – *for decision*

The Conference will be invited to approve the reports related to the UNECE statistical work programme as follows:

(i) Report on the implementation of the UNECE Statistical Programme for 2015 (ECE/CES/2016/15, **adopted by the CES Bureau in February 2016**);

(ii) Reports of the CES Bureau Meetings, progress reports of Teams of Specialists (Steering Groups and Task Forces) and reports of expert meetings.

(b) Programme planning documents for the United Nations Economic Commission for Europe Statistics subprogramme – *for decision*

The Conference will be invited to review and adopt the official planning documents of the Statistics subprogramme prepared in the context of the United Nations secretariat's biennial planning and reporting cycle:

(i) UNECE Statistical Programme for 2016 (ECE/CES/2016/16, as agreed by the CES Bureau in October 2015). The document is in line with the Programme of Work of the Statistics subprogramme for 2016-2017, adopted by the Conference in June 2015 (ECE/CES/2015/16) and approved by the UNECE Executive Committee in January 2016;

(ii) Strategic Framework of the UNECE Statistics subprogramme for 2018-2019 (ECE/CES/2016/17, as agreed by the CES Bureau in October 2015).

11. Selection of topics for seminars to take place during the 2017 Conference of European Statisticians plenary session

The Conference will select topics for the CES seminars in 2017 based on a proposal by the CES Bureau. The proposal will reflect the results of an electronic survey to be carried out by the Secretariat in spring 2016 among the CES member countries and international organizations.

12. Other business

Any additional issues that the Conference needs to be informed of can be taken up under this agenda item.

13. Closing of the meeting

A draft report of the CES plenary session, including the main decisions, will be adopted at the end of the meeting (in English only). A detailed report will be prepared after the Conference and will be sent for comments to all participants. The finalised report will be translated into French and Russian.
