Three main parts:

The duties and mandate of the Directorate General of Migration Management are to:

- ✓ Carry-out activities and actions related to **regular (legal) migration**
- ✓ Carry-out activities and actions related to **irregular (illegal) migration**
- ✓ Carry-out activities and actions regarding the scope and implementation of the protection to be provided to foreigners and stateless who claim for **international protection** and temporary protection to be provided to those in mass influxes.
- ✓ Carry-out activities and actions for the protection of victims of human trafficking and stateless persons
- ✓ Provide secretariat services for the Migration Policies Board and implement the decisions of the Board

TYPES OF INTERNATIONAL PROTECTION

A well-founded fear of being persecuted for reasons of;

- ✓ Race
- ✓ Religion
- ✓ Nationality
- ✓ Membership of a particular social club
- ✓ Political opinion



Europe
(Refugee)

Outside of Europe
(Conditional Refugee)

- ✓ A foreigner shall be granted subsidiary protection because if returned to the country of origin, he/she would;
- ✓ Have been sentenced to death or face the execution of the death penalty
- ✓ Face torture or inhuman or degrading treatment or punishment
- ✓ Face serious threat to himself or herself by reason of indiscriminate violence in situations of international or nationwide armed conflict

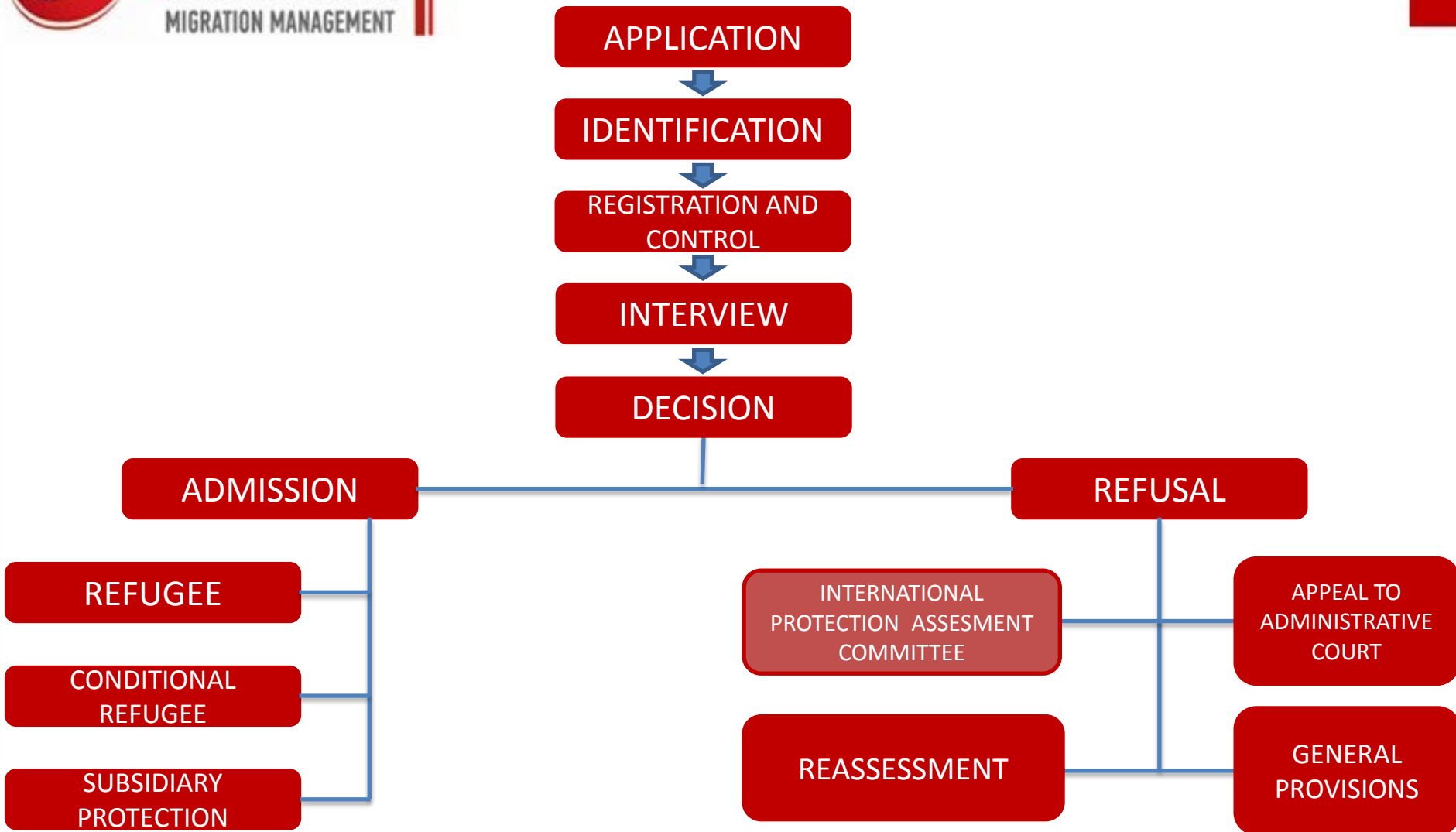

For vulnerable groups, special protection mechanisms in accordance with international standards were established.



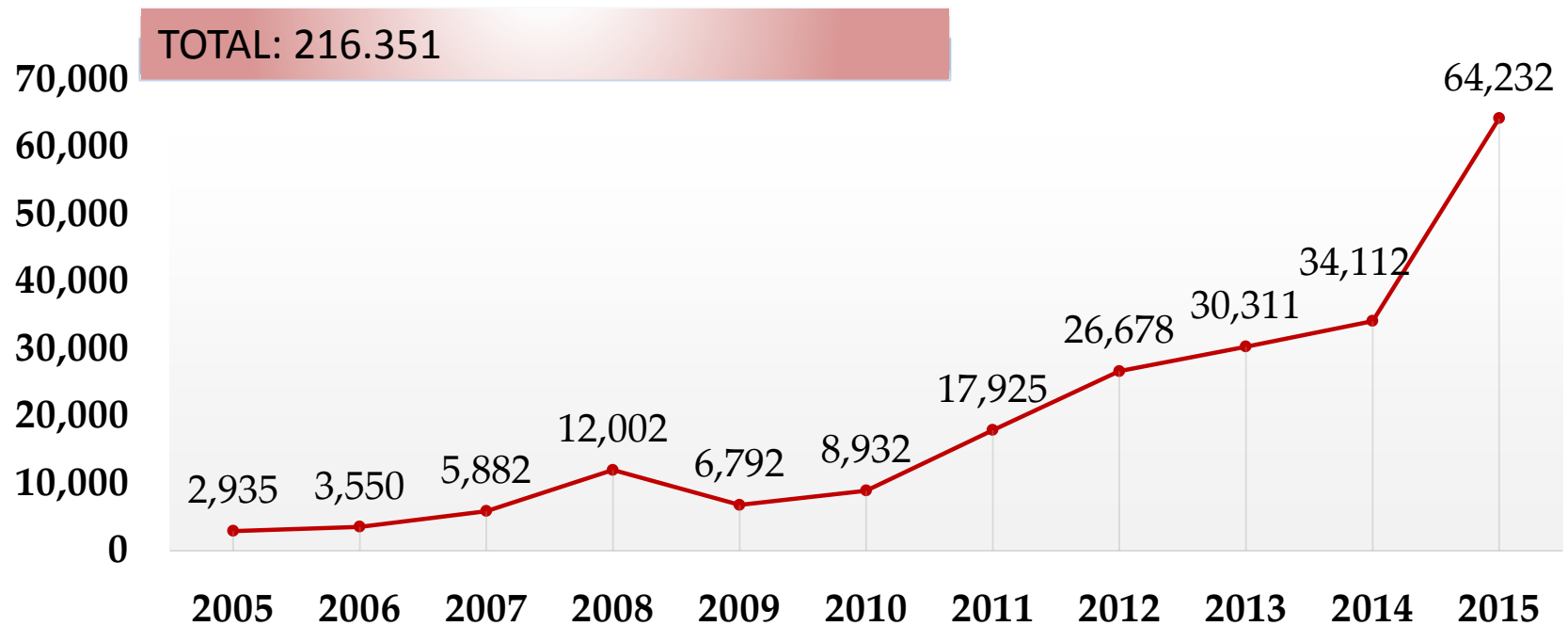
Subsidiary protection status was firstly regulated.

TEMPORARY PROTECTION

- **In the Article 91 of Law No. 6458, the actions to be carried out for:**
- ✓ the reception of such foreigners who are subject to temporary protection into Turkey; ,
 - ✓ their stay in Turkey,
 - ✓ their rights and obligations,
 - ✓ their exit from Turkey,
 - ✓ cooperation and coordination among national and international institutions and organisations,
 - ✓ determination of the duties and mandate of the central and provincial institutions and organisations
- shall be stipulated in a Directive to be issued by the Council of Ministers.

Scope of the Regulation;

- ✓ General Principles and Scope of Temporary Protection
- ✓ Provisions on Temporary Protection Decision and **Termination** of Temporary Protection
- ✓ **Primary Proceedings** To Be Conducted Under Temporary Protection
- ✓ **Services** To Be Provided To Persons Benefiting From Temporary Protection
- ✓ Establishment, Management and Operation of Referral Centers and Temporary Accommodation Centers and Services To Be Provided In **Temporary Accommodation Centers**
- ✓ **Voluntary Repatriation and Departure To A Third Country**
- ✓ Cooperation and Assistance
- ✓ Miscellaneous and Final Provisions

After Temporary Protection Regulation became effective as of 22/10/2014 , temporary protection provisions were begun to be implemented to:

- ✓ **The citizens of the Syrian Arab Republic,**
- ✓ **Stateless persons,**
- ✓ **Refugees who have left Syrian Arab Republic and have arrived at or crossed our borders since **28 April 2011.****

**In the framework of International and Customary Law
Turkey provides temporary protection to Syrian
nationals considering the following three factors:**

Clean acceptance to Turkey within the open border policy



**Implementation of the non-refoulement
principle without exceptions**



**Meeting basic needs of newly-arrived
Syrians in Turkey**



NATIONAL LEGISLATION

- ✓ «Temporary Protection» gained legal basis.
- ✓ «Temporary Protection Identification Document» is issued to those free of charge.
- ✓ This identification document;
- ✓ Provides such foreigners right to stay in Turkey legally,
- ✓ Includes foreigner identification number pursuant to the Law No. 5490 on Population Services of 25/4/2006. Temporary Protection Document shall not be deemed to be equivalent to a residence permit or documents, which substitute residence permits, as regulated by the Law on Foreigners and International Protection.
- ✓ This document shall not grant the right for apply to Turkish citizenship or transition to long term residence permit.

ACTIVITIES AND ACTIONS CARRIED WITHIN TEMPORARY PROTECTION

REGISTRATION PROCEDURES

- ✓ **Registration procedures** are currently on-going in 81 provinces in the coordination of Directorate General of Migration Management.



ACTIVITIES AND ACTIONS CARRIED WITHIN TEMPORARY PROTECTION

REGISTRATION PROCEDURES

- ✓ Registration procedures are carried out in registration centers and mobile service units, thereby **biometric** data including fingerprints and photographs are collected.

Türkiye Cumhuriyeti topraklarına girmiş bulunduksanız, Ülkemize güvenli şekilde sığınarak size ve birliğinize gel-
dığınız aile üyelerinize ülkemiz sınırlarından geçip koruma
sağlanacaktır.

- Bulduğunuz ilde emniyet birimlerinde kayıt merkezle-
rine giderek biyometrik kayıt yaptırmanız ve geçici koruma
kimlik belgesi alınması gerekmektedir.
- Kayıt merkezlerinde oturma belgesi başvurusu yapılarak size
"Yeni Randevu Belgesi" düzenlenir.
- Kayıt randevusunu verildiği tarihte bulunduğunuz ildeki
kayıt merkezlerine müracaat ederek biyometrik kayıt yap-
tırmanız gerekmektedir.
- Biyometrik kayıt işlemlerini tamamladıktan sonra verilecek
kimlik belgesi, ücretsiz sağlık hizmeti, eğitim, sağlık gibi
hizmetlere yararlanma gerekliliği hakkında bilgilendirilecektir.
- Geçici koruma kimlik belgenizi kaybetmiş halde en yakın
kayıt merkezine müracaat etmeniz gerekmektedir.

► REGISTER AND BENEFIT FROM RIGHTS AND SERVICES

You have entered the territory of the Republic of Turkey. Tem-
porary protection will be provided to you and your accom-
panying family members by our country until your return in
safety to your country.

- You are required to approach the registration centers within
the security units in your current province to register biomet-
rically and receive the temporary protection identification
documents.
- Due to possible congestions at the registration centers, you
might be issued a "Registration Appointment Slip".
- On the date of registration appointment, you must approach
the registration center in your current province and register
biometrically.
- Identification document, which will be issued to you upon
completion of your biometric registration proceedings, will
grant you the right to stay in our country and access to ser-
vices/assistance including education and healthcare.
- If you lose the temporary protection identification document,
you must approach the closest registration center.
- Our government established accommodation centers for
you; you are not required to stay in those centers but persons
who are unable to meet their needs will be referred to those
centers.
- If you wish to return to your country, your exit from our
country will be ensured, provided that you approach the re-
gistration centers in your province and fill out the voluntary
repatriation form.

✓ **600.000 information leaflets** were distributed to encourage Syrian nationals for identification and registration procedures and to inform them about their rights and obligations.

✓ To complete the registration of Syrian national, **high-level briefing meetings** were organised with governorates, particularly Istanbul.

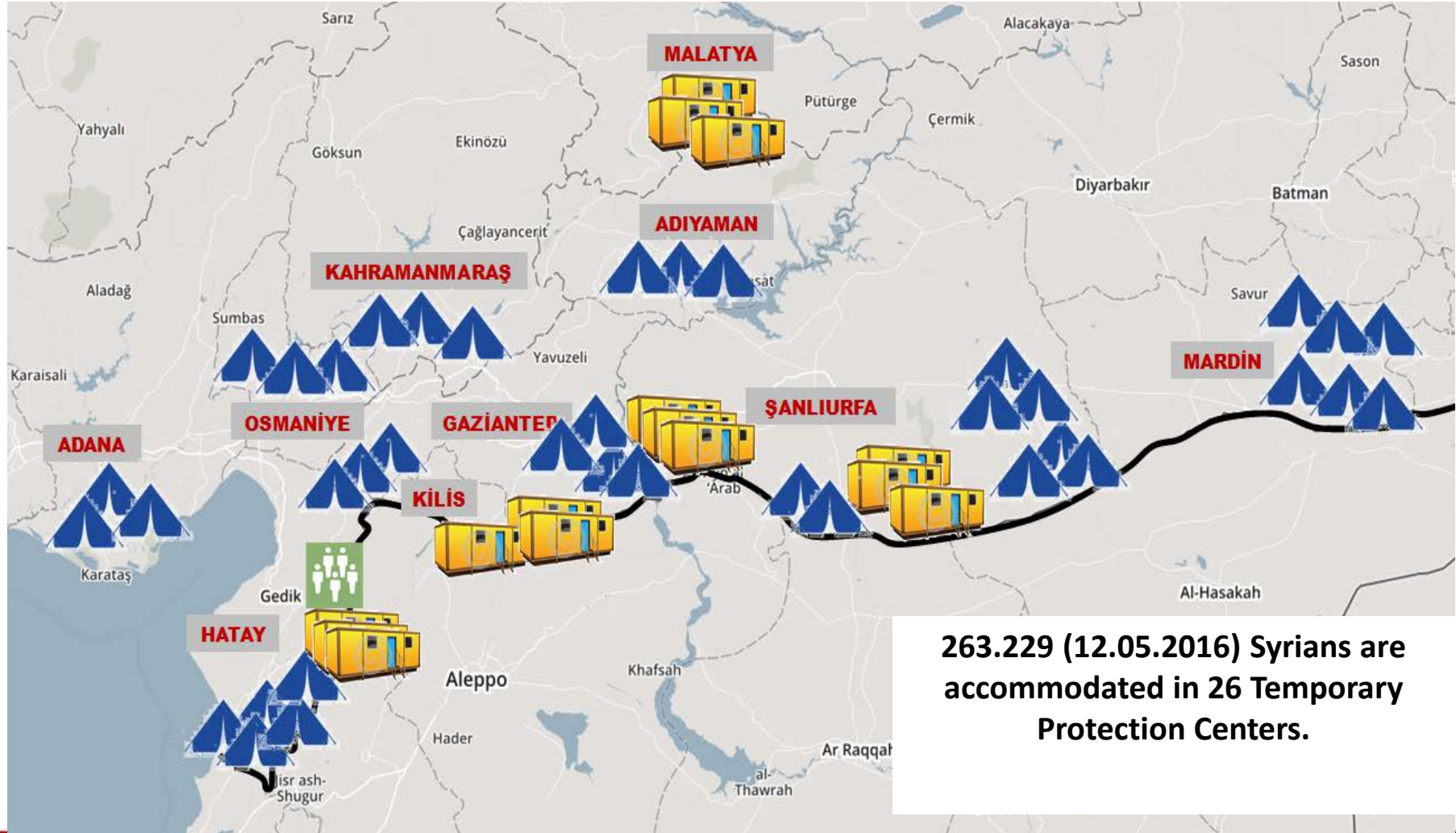
RIGHTS AND SERVICES PROVIDED TO FOREIGNERS UNDER TEMPORARY PROTECTION

Foreigners are provided with the following services:

- ✓ **Health**
 - ✓ **Education**
 - ✓ **Access to labor market**
 - ✓ **Social assistance and services**
 - ✓ **Subscription and banking procedures**
 - ✓ **Interpretation etc.**
- ❖ Excluding education and emergency health services, access to other rights by those, who do not comply with their obligations may be restricted.

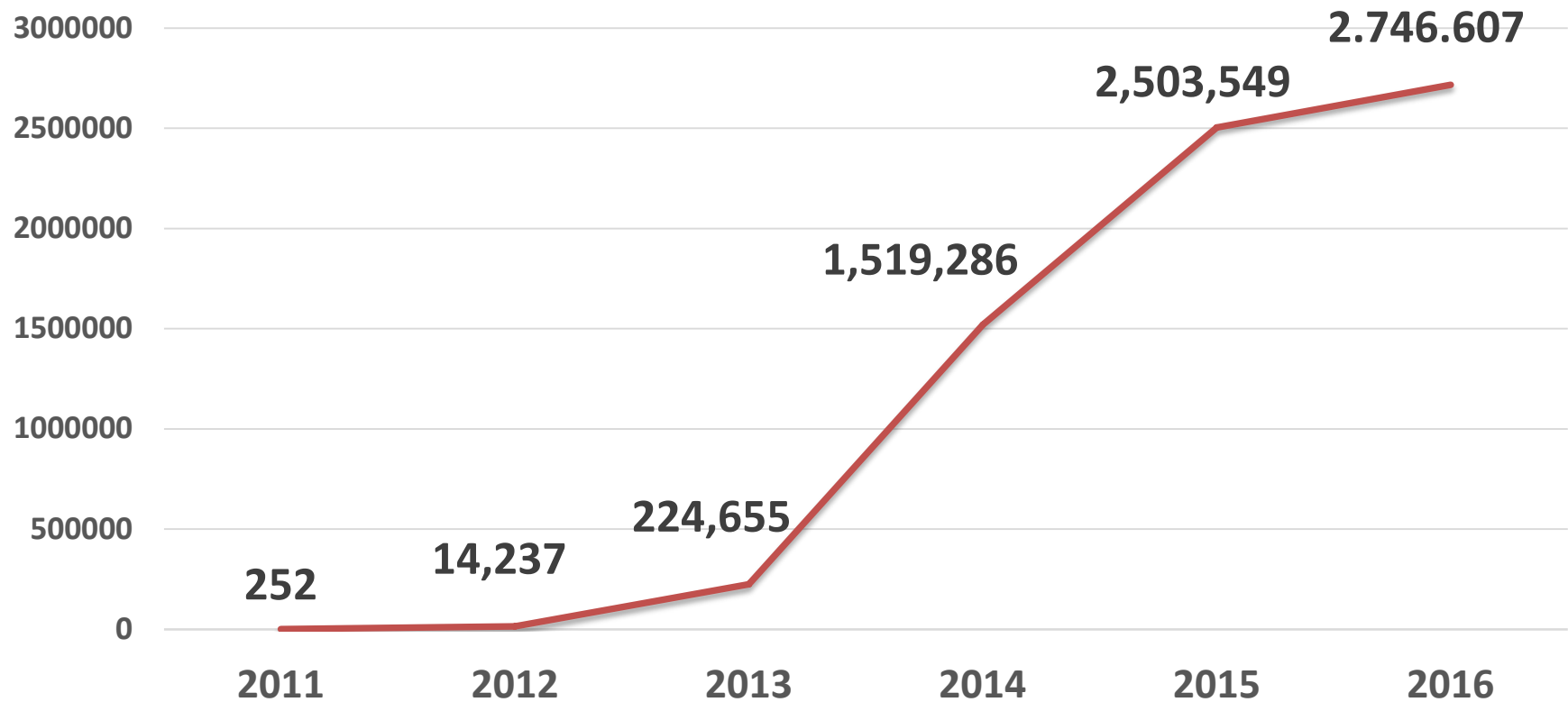

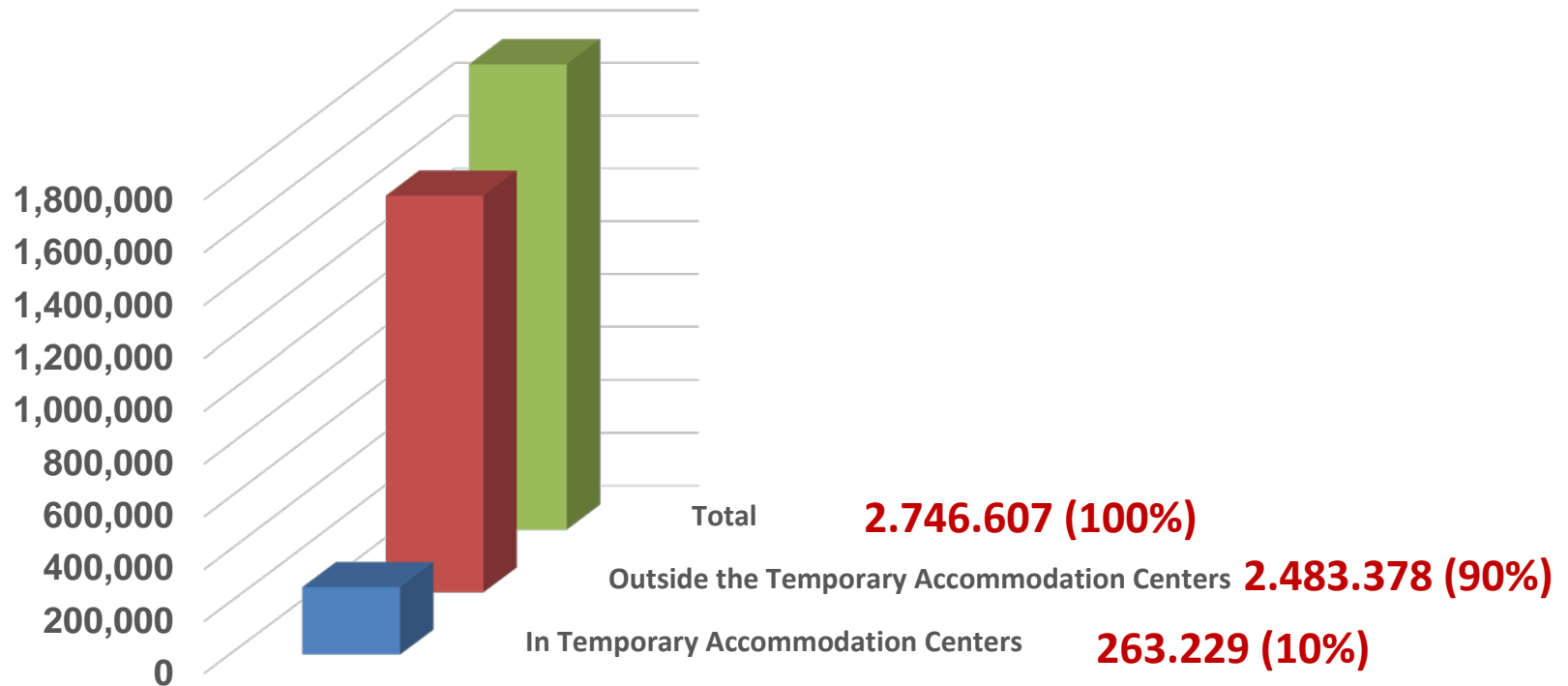
