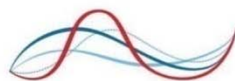

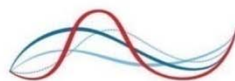

## *Introduction*

1. Croatia is in process of harmonisation of the official Croatian Statistical system with the European statistical system and European Statistics Code of Practice;
2. Croatian current mid – term Programme of Statistical Activities for the period 2008-2012 is in accordance with The Eurostat Statistical Requirements Compendium 2006;
3. The Statistical requirements compendium is a well- established reference document for the *acquis* in statistics, and summarises the key reference information for European statistical production,
4. Eurostat, the statistical office of the European Union, updates the Compendium every year to take into account new legislation and other developments relevant for European statistics.





## Current situation regarding planning

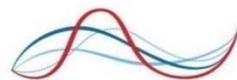
1. Long-term goals: Development Strategy of Official Statistics of the Republic of Croatia 2004-2012 (Croatian Parliament adopted on its session of February 11 2005);
2. Medium-term planning: Programme of Statistical Activities of the Republic of Croatia ( Croatian Parliament adopted on its session of 21 May 2008);
3. Short term planning: Annual Implementing Plan 2011 – derived from the Programme (Croatian Parliament adopted on its session of 24 June 2011);
4. Internal Annual Work Plan in Economic Statistics Directorate for 2012 according to the deadlines of Eurostat Transsmission programme





## *Future plans - The SNA 2008 implementation Plan*

1. Medium-term planning: Programme of Statistical Activities of the Republic of Croatia for the period 2013 -2017, in accordance with the European statistical programme 2013-2017 as well as latest Eurostat Statistical Requirements Compendium,
2. Annual Implementing Plan 2012 – derived from the Programme
3. Internal Work Plan in Economic Statistics Directorate for 2013 – 2017 in accordance with the Eurostat Transsmission Programme





## *Future plans - The SNA 2008 implementation Plan*

1. Programme of Statistical Activities of the Republic of Croatia for the period 2013 -2017 – it will consist of
  - elaborated concept of the statistical products
  - methodological concept and compilation process
  - Institutional framework





# *Future plans - The SNA 2008 implementation Plan*

*Elaborated concept of the statistical products*

Elaboreted by the statistical theme and structure, responsible producer of official statistics with description of statistical product





# *Future plans - The SNA 2008 implementation Plan*

## *Methodological concept and compilation process*

- Review of the methodology changes from SNA 1993 to SNA 2008 and consequently ESA 1995 to ESA 2010
- Develop methodology according to the changes
- Determine priorities according to the requirements and availability of data sources
- Trainings, seminars, task forces in Eurostat ( for the changes)
- Revision according to the changes ( new calculations and compilation process, back casting series, followed by European statistical Programme)







# *Future plans - The SNA 2008 implementation Plan*

## *Institutional framework*

- Review all administrative data gathering from Central Bank, Ministry of Finance, Financial Agency and other institutions in statistical system – for the changes from SNA 1993 to SNA 2008 and ESA 1995 to ESA 2010;
- Synchronise the changes between institutions





# *Future plans - The SNA 2008 implementation Plan*

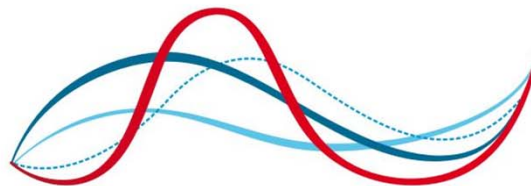
2. Annual Implementing Plan 2012 – derived from the Programme

- Activities derived from the Programme – description of all activities in details

3. Internal Work Plan in Economic Statistics Directorate for 2013 – 2017 in accordance with the Eurostat Transmission Programme

- Detailed plan of work to be done by responsibility and according to the deadlines
