Updating the Law on Official Statistics of the Republic of Azerbaijan

Geneva, 9 April 2019



Introduction

- The current Law on Official Statistics of the Republic of Azerbaijan was adopted on 18 February 1994.
- The law regulates legal relations in the field of official statistics, defines the powers and functions of state statistics bodies.
- In order to improve legal regulation in the field of production and dissemination of official statistics, adaptation to new conditions and requirements, the Law was amended 14 times.
- The latest additions and changes to the Law were made on 12 October 2018.

Introduction (*continued*)

- In general, the current Law on Official Statistics provides the necessary basis for the State Committee on Statistics of the Republic of Azerbaijan (GKS) to produce high-quality, international standards-compliant statistical information.
- At the same time, the need to improve the national system of official statistics in order to improve information support for making decisions in the context of global political, economic and social processes led to a revision of the legislation in the field of official statistics.

The main disadvantages of the current law

- ◉ There are no clear differences between official statistics and administrative data
- ◉ The term “official statistics” requires a more specific definition
- ◉ Other producers of official statistics are not identified
- ◉ The role of the GKS in coordinating activities in the production of official statistics is not clearly defined
- ◉ The basic principles of official statistics are not reflected
- ◉ Not all terms and concepts are covered by definitions
- ◉ The forms, rules and sources of data collection and processing are not fully defined
- ◉ Principles of confidentiality of statistical information are not fully regulated

Recommendations on the improvement of the Law, based on the Global Assessment of the National Statistical System of Azerbaijan

As a result of the Global Assessment of the National Statistical System of Azerbaijan, carried out by Eurostat, UNECE and EFTA in 2017, the following recommendations were formulated to improve the national Law on Official Statistics:

- Revision of the Law in accordance with the Generic Law on Official Statistics (GLOS) approved by the Conference of European Statisticians at the plenary meeting on 29 April 2016
- Revise the definition of the term “official statistics”
- Ensure the application of the statistical law to all aspects of the production and dissemination of official statistics in the country, regardless of who its producer is and what methodologies and sources are used

Recommendations on the improvement of the Law, based on the Global Assessment of the National Statistical System of Azerbaijan (continued)

- Establish the right of the GKS to participate in consultations on the design of new sources of administrative data or on making changes to existing sources of administrative data
- Define the boundaries of the National Statistical System, because the Law and the current program do not provide complete clarity of which institutions provide official statistical information, and which are the providers of administrative data
- In the revised Official Statistics Law, provide direct recognition of the key role that the Population Register can play in supporting the development of statistics based on administrative sources

New draft law on official statistics of the Republic of Azerbaijan

- The draft Law on Official Statistics of the Republic of Azerbaijan was developed on the basis of the Generic Law on Official Statistics (GLOS), taking into account the recommendations of the Global Assessment of the National Statistical System
- The draft law contains 12 chapters and 35 articles.

Discussion and coordination in the process of preparing the draft law

- The draft law was discussed at the Statistical Council and, at their suggestion, GKS created a working group with representatives of the GKS, the Ministry of Internal Affairs, the Ministry of Ecology and Natural Resources, the Ministry of Education, the Ministry of Justice, the State Customs Committee and the Central Bank
- The latest version of the draft law was agreed after making changes proposed by the Working Group
- At the same time, within the framework of the project “EU Assistance to the State Committee on Statistics of the Republic of Azerbaijan on Achievement of European Standards”, an international examination of the draft Law was also conducted
