



# Preparations for the 2020 General Population Census in Ukraine

Ukraine will conduct the 2020 census based on the methodological principles applied in EU countries in line with the recommendations of Eurostat and the Conference of European Statisticians.

#### Basis for the general population census in Ukraine:

- Law of Ukraine on the General Population Census; the population census is based on the decision of the Cabinet of Ukraine, adopted at least three years in advance
- Order No. 581-p of April 9, 2008, of the Cabinet of Ukraine on the 2020 General Population Census in Ukraine
- Order No. 424 of April 18, 2018, of the Cabinet of Ukraine on the Establishment of the Interagency Commission to Assist in the General Population Census in Ukraine
- Order No. 504-p of July 18, 2018, of the Cabinet of Ukraine on the Pilot Population Census in Ukraine





#### The pilot population census is scheduled for 2019:

- Upgrade to the GPC software to allow for recent changes in the legal base, and economical, social, demographic, and migration processes
- Inability to activate licenses and use the industrial package of ABBYY FlexiCapture 10 Census\_Edition to process census data (ООО Аби Украина ЛТД, which used to activate licenses for this product, is now covered by the three-year sanctions, according to Decision of April 28, 2017, of the National Security and Defense Council of Ukraine)
- The use of modern innovative technologies; particularly, the use of mobile electronic devices (CAPI method) and the Internet (CAWI method) for the population census

The 2020 GPC will document the population as from 00 hours of November 10, 2020.

From 10 through 30 of November 2020, respondents will selfreport data as per the program of online population census.

From 3 through 23 of December 2020, the temporary census personnel will visit residential buildings and residential quarters in other buildings and will take census data by documenting respondents' answers on tablets.
