INTERNATIONAL DIALOGUE ON FORESTS, SUPPORT TO THE GLOBAL AND REGIONAL PROCESSES

(Item 5 of the provisional agenda)

Note by the secretariat

The present document reviews the activities undertaken by the Timber Committee and the European Forestry Commission in support to the global and regional forest dialogue. The Committee will be invited to agree in future support to be provided by ECE/FAO.

INTRODUCTION

- 1. In the mid 1990s, the Timber Committee and the European Forestry Commission decided to give over-riding priority to supporting the international dialogue on forests. This report is the most recent of the annual reports on this topic presented for the Timber Committee's attention and decision.
- 2. The Committee is invited to take note of the actions undertaken in support of the global and regional forest dialogue and agree on future support to be provided by ECE/FAO.

GLOBAL FOREST DIALOGUE

- 3. The UN Forum on Forests (UNFF) continues its work. A ministerial level segment at UNFF2 in spring 2002 agreed on a message to the World Summit on Sustainable Development (WSSD) to be held in Johannesburg in August/September 2002. UNFF3 will be held in Geneva in April 2003. UNFF is focusing on implementation, at the national and international levels, of the proposals for action agreed by the Intergovernmental Forum on Forests (IFF). UNFF and IFF have at several times welcomed regional cooperation in furtherance of their aims, but have not made specific recommendations about regional activities: the link under UNFF between global and regional activities (such as those carried out by ECE/FAO) is not well defined at present.
- 4. The main approach adopted by ECE/FAO until now has been to try to implement at regional level activities which have the same objectives as those identified at global level by IFF or UNFF. In 1998, the secretariat carried out a systematic survey of the IFF proposals for action, and considered whether the ECE/FAO programme should be adjusted in the light of this review. A number of activities were introduced or strengthened in the light of this review, notably the seminar on strategies to stimulate and promote the sound use of wood as a renewable and environmentally friendly raw material (a direct quotation from the IFF proposals) and on trade and the environment (see TIM/1998/4)
- 5. A new, less detailed statement of global level political priorities is the paragraph on forests in the Plan of Implementation for the WSSD. Annex I presents this paragraph, with commentaries on how ECE/FAO is implementing these objectives at the regional level.
- 6. There is a more direct link between the regional and global level through the FAO structure. FAO not only provides a major global policy forum, the Committee on Forests (COFO), but also leads the work of the Collaborative Partnership on Forests (CPF). The European Forestry Commission, the Timber Committee's sister body, is a subsidiary body of COFO, and ECE/FAO Geneva performs the functions of FAO regional forest officers in other regions. In general FAO's structure and organisation is becoming increasingly decentralised. The global-regional link within FAO essentially takes two forms:
 - EFC recommendations and conclusions are put before COFO. In particular EFC, like the other regional forestry commissions is expected to articulate regional policy issues as input to the discussion at COFO. In recent years, the "regional dimension" at COFO has received increasing emphasis;

- Several ECE/FAO activities and outputs are closely integrated with global work and are indeed direct
 inputs to global totals. This applies in particular to the Joint Forest Sector Questionnaire, to the forest
 resource assessment work and to the outlook studies.
- 7. In addition ECE/FAO staff maintain close contact with counterparts and are asked to participate on an individual basis to global efforts, such as the *State of the World's Forests* (SOFO), work on definitions etc.
- 8. Thus it appears that ECE/FAO makes a significant contribution to the global dialogue on forests by:
 - Carrying out regional level work along the lines identified as important at the global level; and
 - Contributing to FAO global work, notably COFO, statistics, FRA and outlook studies.
- 9. However the interface between global and regional work at present is not very clear: in particular it is not clear to what extent UNFF really builds on, or benefits from, regional input.

10. The Committee may wish to:

- Provide guidance to the secretariat on the activities described above to make them as relevant as possible from a global as well as regional perspective;
- Draw the attention of UNFF to the regional level input from ECE/FAO and request it to indicate whether the present arrangements are satisfactory from the UNFF point of view or whether modifications would be desirable.

FOLLOW-UP TO WORLD SUMMIT ON SUSTAINABLE DEVELOPMENT

11. It is, of course, not possible at present to predict the outcome of WSSD. Nevertheless, the "proposed elements for the political declaration of WSSD" at present (mid July) available contain a reference to the regional level. In the draft, the ministers "welcome the emergence of stronger regional groupings and alliances to promote sustainable development and encourage further regional cooperation to promote sustainable development, including through the UN regional commissions." It is therefore possible that ECE may be called on to play a more pronounced role as regards the promotion of sustainable development in the region. Indeed it has already been decided that the theme of the Commission's annual session in 2003 will be sustainable development. In view of the Timber Committee's long experience in sustainable development of the forest/timber sector, as regards monitoring and analysis of the situation, trends and policies, and the holistic approach which characterises its work, it is possible that timber/forest issues would be treated as a case study of a holistic approach to sectoral problems in any work undertaken at the Commission level.

SUPPORT TO THE MINISTERIAL CONFERENCE ON PROTECTION OF FORES TS IN EUROPE (MCPFE)

- 12. ECE/FAO and MCPFE have been working together ever more closely since the mid 1990s, to mutual benefit. This is natural as both concern intergovernmental cooperation, with very similar geographic scope and the same major objective, the promotion of sustainable forest management in the region.
- 13. About a third of the items in the MCPFE work programme approved in October 1999 are to be implemented by ECE/FAO: the status of these items is summarised in the annex, which presents the MCPFE programme as agreed with an extra column indicating what actions have been carried out by ECE/FAO. The following remarks are relevant:
 - ECE/FAO staff members participated very actively in the revision of the MCPFE indicators of sustainable forest management, both in the four workshops and as a member of the Advisory Group, transmitting the experience of TBFRA, and ensuring that the revised indicators took account of that experience. They will also transmit the ideas generated during the revision process to subsequent FRA work at the regional and global level;
 - ECE/FAO staff also participated actively in the preparation of the MCPFE classification of protected and protective forest; the network of TBFRA correspondents is being used to collect and validate the data which will be presented to the Ministerial Conference;
 - The Joint FAO/ECE/ILO Committee team of specialists on participation provided an opportunity to clarify
 the concepts and principles of participation in European circumstances, for the first time, and made
 possible a significant improvement in understanding of an area recognised as increasingly central to forest
 management;
 - Several of the Joint FAO/ECE/ILO Committee's existing activities, notably but not exclusively in the social field, were recognised as significant inputs to the promotion of SFM at the regional level, as was the work of the Forest Communicators Network (FCN);
 - The seminar on women in forestry, also under the auspices of the Joint Committee, was one of the very few examples of mainstreaming the gender issue in the forest sector, despite the priority accorded to these questions by the international community in general;
 - The report of the FCN (then known as the PR team) on the competitive climate for wood, and the planned seminar on sound use of wood (Romania, March 2003), represent a contribution to understanding of the downstream part of the sector, which is sometimes lost to view in the discussions of SFM;
 - The ECE/FAO team of specialists on countries in transition meets regularly to review developments and
 was a partner in the organisation of the workshop in Debe, Poland in September 2001, which not only
 provided an excellent opportunity for exchange of experience but also generated specific
 recommendations for the attention of MCPFE. The database on assistance to countries in transition has
 been maintained and developed;
 - There has been regular coordination and exchange of information between ECE/FAO and the Vienna Liaison Unit, with mutual participation in meetings etc.
- 14. There are many ongoing cooperative activities, summarised below:

- **information on recent developments for Europe's forests:** Interim TBFRA data were provided for the Lisbon Conference in 1998. Now an enquiry to the TBFRA correspondents has been set in motion to collect updated information for the key parameters to provide similar information for the Vienna Conference. ECE/FAO is leading the effort with its partners, notably ICP Forest.
- Policy dialogue at EFC sessions: need for country information: A regular item on the agenda of the EFC (next meeting, Barcelona, 4-8 November 2002) is a review of recent developments in policy and institutions as well as a dialogue to articulate emerging issues at the regional level, for transmission to COFO. There is also an in-session seminar, this time on the theme of the information needs of the international forest policy dialogue. Normally this item is based on national reports submitted by countries, but it has been agreed, that, in order to minimise the reporting burden on countries, the synthesis prepared by the ECE/FAO secretariat for the EFC session be based on the reports submitted by countries for MCPFE on implementation of the various MCPFE resolutions.
- Outlook study (EFSOS), policy scenarios and cross-sectoral approaches: The European Forest Sector Outlook Study, at present being prepared, pays particular attention, in addition to the traditional analysis of the outlook for supply and demand and for the forest resource, to scenarios for policies, both "internal" to the forest sector and "external". It has identified 13 policy scenarios, their likelihood of occurring and their possible impact. It has been proposed that a workshop be organised to present the output of EFSOS to the MCPFE community, and to obtain their reaction to the ideas and conclusions. The Committee and Commission will be informed of the latest developments in this regard and asked to comment.
- Forests and forestry in central and eastern European countries: ECE/FAO will prepare a short report on the implementation of resolution H3, referring in particular to the conclusions and recommendations of the workshop in Debe, Poland. The conclusions of the Debe workshop addressed to MCPFE, as well as the EFSOS analysis, show that developments for these countries will be one of the most significant factors for the sector at the regional level over the next decade or so.
- 15. The Committee is invited to comment on past and proposed future cooperation between ECE/FAO and MCPFE, and provide guidance as necessary.

CONCLUSION

- 16. Almost all activities in the ECE/FAO integrated programme contribute, directly or indirectly, to supporting the global and regional forest dialogues, within the limits fixed by the mandates of the Committee and Commission and the resources available.
- 17. The Committee is invited to take note of these activities and to make recommendations as to how this contribution could be increased.

Annex 1

Forestry issues in the Draft Plan of Implementation for the WSSD

Set out below are the points concerning forestry in the draft plan and next to them, comments on how ECE/FAO is or could implement activities along the lines laid down in the WSSD preparatory process.

43. [Agreed] Forests and trees cover nearly one third of the Earth's surface. Sustainable forest management of both natural and planted forests and for timber and non-timber products is essential to achieving sustainable development and is a critical means to eradicate poverty, significantly reduce deforestation and halt the loss of forest biodiversity and land and resource degradation, and improve food security and access to safe drinking water and affordable energy, highlights the multiple benefits of both natural and planted forests and trees and contributes to the well-being of the planet and humanity. Achievement of sustainable forest management, nationally and globally, including through partnerships among interested governments and stakeholders, including the private sector, indigenous and local communities and non-governmental organizations, is an essential goal of sustainable development.

The statement in the first line is based on data collected and validated by a process in which ECE/FAO has played a leading part. Some of the aspects mentioned, including biodiversity, energy, multiple benefits, partnerships, and role of the private sector, are already covered in one way or another by ECE/FAO. Poverty and food security issues are covered by analysis of economic viability of forestry. Access to safe drinking water has not so far figured in the programme.

This would include actions at all levels to:

(a) [Agreed] Enhance political commitment to achieve sustainable forest management by endorsing it as a priority on the international political agenda, taking full account of the linkages between the forest sector and other sectors through integrated approaches;

The integrated approach to cross sectoral issues is at the heart of the EFSOS policy study work, which should help governments understand this complex issue.

(b) [Agreed] Support the United Nations Forum on Forests, with the assistance of the Collaborative Partnership on Forests, as key intergovernmental mechanisms to facilitate and coordinate the implementation of sustainable forest management at the national, regional and global levels thus contributing, *inter alia*, to the conservation and sustainable use of forest biodiversity;

This document sets out how ECE/FAO supports UNFF and CPF work

(c) [Agreed] Take immediate action on domestic forest law enforcement and illegal international trade in forest products, including in forest biological resources, with the support of the international community, and provide human and institutional capacity-building related to the enforcement of national legislation in those areas:

ECE/FAO has not been active in the field of forest law enforcement

(d) [Agreed] Take immediate action at national and international levels to promote and facilitate the means to achieve sustainable timber harvesting, and to facilitate the provision of financial resources and transfer and development of environmentally sound technologies, and thereby address unsustainable timber harvesting practices;

The Joint FAO/ECE/ILO Committee aims to transfer and develop environmentally sound technologies for sustainable timber harvesting through the exchange of information and experience.

(e) [Agreed] Develop and implement initiatives to address the needs of those parts of the world that currently suffer from poverty and the highest rates of deforestation and where international cooperation would be welcomed by affected Governments;

A few parts of the ECE region, notably in central Asia, suffer from poverty and deforestation. However, ECE/FAO does not seem to have a comparative advantage in providing assistance to these countries' forest sector.

(f) [Agreed] Create and strengthen partnerships and international cooperation to facilitate: the provision of increased financial resources, transfer of environmentally sound technologies, trade, capacity-building, forest law enforcement and governance at all levels, and integrated land and resource management to implement sustainable forest management, including the Intergovernmental Panel on Forests (IPF)/Intergovernmental Forum on Forests (IFF) proposals for action;

ECE/FAO has many long standing partnership arrangements and organized a seminar on partnerships in Brussels in spring 2002. Trade and capacity building issues are covered by the work in many respects.

(g) [Agreed] Accelerate implementation of the IPF/IFF proposals for action by countries and by the Collaborative Partnership on Forests, and intensify efforts on reporting to the Forum to contribute to an assessment of progress in 2005;

This document details ECE/FAO cooperation with CPF. It is likely that any international reporting for an assessment of progress, once decided, would involve ECE/FAO in some way, probably through TBFRA data

(h) [Agreed] Recognize and support indigenous and community based forest management systems to ensure their full and effective participation in sustainable forest management;

Community based forest management systems were included in the Joint Committee work on public participation in forest decision making.

(i) [Agreed] Implement the Convention on Biological Diversity's expanded action-oriented work programme on all types of forest biological diversity in close cooperation with the UNFF, the CPF members and other forest-related processes and conventions with the involvement of all relevant stakeholders.

Several of the parameters collected by TBFRA serve as indicators of forest biodiversity.
