REVIEW OF ACTIVITIES SINCE THE SIXTIETH SESSION AND PROGRAMME OF WORK FOR 2004 TO 2007

(Item 7 of the provisional agenda)

Note by the secretariat

The present document presents:

- an account of work carried out since the Committee's sixtieth session and a number of specific points drawn to the Committee's attention, which it may consider discussing; and
- the integrated programme of work of the Timber Committee and the FAO European Forestry Commission for the period 2004 to 2007, for review and endorsement by the Committee.

INTRODUCTION

- 1. The Committee and the Commission are expected to review implementation of the ECE/FAO integrated programme over the last year, and approve the programme for the period 2003 to 2004. According to the modalities agreed at the Strategic Review, the whole programme need not be reviewed and approved in detail by the Committee and the Commission, as the strategic direction has been agreed for the period to 2004, the work areas 1- 3 are guided by the Working Party and work area 4 by the Joint Committee, and the bureaux are responsible for overseeing implementation within the broad lines agreed. Under this agenda item the Committee and Commission should therefore:
 - take note of the activities under the integrated programme of work between September 2002 and November 2003, and provide more detailed guidance for the activities in work area 5 (for which no subsidiary body provides guidance);
 - discuss those policy relevant issues which need to be discussed at the intergovernmental level;
 - take note of the programme of work for 2002-2004 presented by the secretariat with the endorsement of the bureaux (see bureaux report, posted on the website); and
 - in view of the Strategic Review to be carried out in 2003-2004 (see TIM/2003/3), no new activities are proposed for the period after 2004 and all time-limited activities end in 2004.
- 2. The programme of work discussion of the Committee are based on:

PART I

PART II

UNECE TIMBER COMMITTEE AND FAO EUROPEAN FORESTRY COMMISSION INTEGRATED PROGRAMME OF WORK, 2003-2007

• A presentation of the integrated programme of work for the period 2003-2007, as of July 2003. The programme has been endorsed by the bureaux and takes into account the recommendations of the Economic Commission for Europe at its fifty-ninth session (see item 2 of the provisional agenda), it includes the broad programme overview, the detailed plans for each work area, the allocation of secretariat resources between programme elements, and the mandates of teams of specialists.

The Committee is invited to review and endorse the integrated programme according to the modalities developed during the Strategic Review process. It should bear in mind that all activities scheduled for the period after October 2004 are likely to be changed in the light of the Strategic Review, which will consider priorities, resources and methods of work.

PART I

ACHIEVEMENTS OF THE PERIOD OCTOBER 2002-SEPTEMBER 2003, AND POINTS FOR DISCUSSION

Work Area 1: Markets and Statistics

- Forest Products Annual Market Analysis, 2002-2004 (FPAMA) production revised: draft before Timber Committee Market Discussions on website and final printed version, with forecasts from TCMDs, at end of year.

- Timber Committee Market Discussions conducted based on presentations circulated before the meeting. Documented through Timber Committee Market Statement and press release (October 2002). To be repeated in October 2003.

Work Area 2: Forest Resource Assessment

ACHIEVEMENTS IN 2002/2003

- The ECE/FAO contribution to planning and preparation of the global FRA 2005 update was the main focus during the reported period. In accordance with the recommendations of the global FRA expert consultation "Kotka-IV" (July 2002) the global FRA advisory group (AG) was set up and held its first meeting in Nairobi (Kenya) in October 2002, and the second meeting in Rome in March 2003. The UNECE/FAO was represented at the AG meetings by the secretariat and members of the regional FRA Team of Specialists. The AG technical advice and recommendations are taken into full consideration when planning and outlining the FRA 2005 scope, coverage and methodology.
- The report on the "State of Europe's Forests" reviewing the situation of sustainable forest management in Europe was submitted to the Fourth Ministerial Conference on the Protection of Forests in Europe.

The report was based on updated and validated FRA-2000 information, which was collected by ECE/FAO during the years 2002-2003. The information supplied included the latest FRA statistics, as well as the analysis of this information, which constituted an important part of the reporting to the Ministerial Conference. The statistical data provided, responded to the majority of the pan-European criteria and quantitative indicators for SFM. This work has also served to updating the global FRA dataset.

- Assessment guidelines for protected and protective forests and other wooded land in Europe were elaborated
 on the basis of the analysis of national data reported in the process of the regional FRA-2000 and reported to
 MCPFE-2003.
- The study "Analysis of Long-term Historical Changes in European Forest Resources" is at the stage of publication. As noted by the Joint FAO/ECE Working Party, this study is a good example of synergies between the two work areas of the UNECE/FAO Integrated Programme of Work (FRA and EFSOS).
- The regional FRA-2000 information posted on Internet at the ECE Timber Committee website has taken one of the leading positions in UNECE according to "hits", "downloads" or "visits" during the last years.
- The UNECE/FAO regional FRA Team of Specialists (ToS) meeting is to be held in Dresden in September 2003. The ToS has to define what FRA work has to be implemented in the forthcoming years at the regional level, additionally to what is to be covered by the global FRA 2005.

Points for discussion:

• The Committee is invited to discuss the UNECE/FAO regional FRA work in the context of the new approaches and comprehensive coverage of the Global FRA aiming to include "information on all aspects of forest resources", in line with the recommendations of the Sixteenth Session of FAO Committee on Forestry (COFO).

Work area 3: European Forest Sector Outlook Studies (EFSOS)

ACHIEVEMENTS IN 2002/2003

The following activities were undertaken, or will be undertaken, during the period between September 2002 and October 2003:

- Since September 2002 the work was focussed on finalising the EFSOS Discussion Papers and the main EFSOS report. (see TIM/2003/3 for more details). Together with the EFSOS Team of Specialists, efforts were made to provide the analytical outcomes on forest resources, forest products markets and policy scenarios with as little delay as possible while aiming for a reasonable level of quality.
- Two EFSOS publications were released under the Geneva Discussion Papers series: A long-term "Forecasts of Economic Growth…" in European countries, which provides the required input for the econometric modelling and a special study about "Employment trends and prospects…". Three Discussion Papers are in the publishing process, another three in final editing and two, including the

EFSOS main report, are in final drafting. These reports will be provided to the Timber Committee session by mid September.

- Efforts were made through the end of 2002 to run various additional complementary activities, such an outlook case study on the Russian forest sector and a synopsis of common legal issues in forestry legislation.
- Additional funds were provided at the end of 2002 by the Swedish government. The funds are mainly directed at further analysis of developments in the Eastern European forest sector.
- EFSOS activities and draft outcomes were presented to the session of the Joint UNECE/FAO Working Party on Forest Economics and Statistics in February 2003 as well as to the Joint Bureaux meeting of the ECE Timber Committee and FAO European Forestry Commission in March 2003. The Working Party approved the activities and commented on the draft outcomes and welcomed the launch of a special study on Eastern Europe "Progress towards a market Economy in Eastern Europe", based on financial support by the Swedish government. The bureaux meeting suggested focusing all available resources on finalising the Discussion Papers and the main EFSOS report.
- The annual EFSOS meeting took place at the end of April 2003 in Geneva. The meeting reviewed in
 detail the EFSOS activities and outcomes, discussed policy relevant conclusions and made
 adjustments to the work plan, taking into account the above mentioned transfer of the coordinator.
 FAO HQ agreed to provide special support to EFSOS.

The following issues are brought to the attention of the Committee:

- Under item 4 of the Provisional Agenda, delegations are invited to discuss the EFSOS activities and outcomes, notably to comment on the draft main EFSOS report, in particular the policy relevant conclusions and the planned workshop.
- Pending the Strategic Review, there are at present no other activities on European Forest Sector Outlook Studies planned. This is reflected in the attached programme of work. The Committee may however indicate areas for future follow up, especially to facilitate the Strategic Review process.

Work area 4: Technology, management and training

ACHIEVEMENTS IN 2002/2003

Activities under this work area are guided by the Joint FAO/ECE/ILO Committee on Forest Technology, Management and Training, which held its twenty-fourth session in Ennis, Ireland in September 2002, just before the session of the Timber Committee and that of the European Forestry Commission.

- Seminar on Partnerships in Forestry, Brussels, Belgium, June 2002.
- Seminar on afforestation in the context of sustainable forest management, Ennis, Co. Clare, Ireland, September 2002.

- Workshop on Forest Operation Improvements in Farm Forests, 9 -14 September 2003, Logarska Dolina, Slovenia.
- Seminar on Close to Nature Forestry, 14-19 October 2003, Zvolen, Slovakia.
- Steering Committee of the Joint FAO/ECE/ILO Committee on Forest Technology, Management and Training, 16th session, 12-13 October.
- International Forest Fire News (IFFN) No. 26, January-June 2002. No. 27, July-December 2002 and No. 28, January-June 2003 (in press).
- The FAO/ECE/ILO Team of Specialists on Forest Fire, with a variety of partners, established 9 regional wildfire networks, helped to organise a Workshop on Multilateral Assistance against Forest Fires in the Mediterranean Basin, Zaragoza, Spain 10-11 June 2003 and contributed to the 3^d International Wildland Fire Conference and Global Fire Summit; Sydney, Australia 4-8 October 2003.

There is a proposal to set up a team of specialists on the role of women in forestry for a 2-year period, for which resources have already been secured. This proposal will be considered by the Steering Committee of the Joint Committee in October. The proposal is in accordance with the ECE cross-sectoral emphasis on gender issues.

The following issue is brought to the attention of the Committee:

• The Committee may also consider how the 50th anniversary of the Joint Committee in 2004 could be used as an opportunity to highlight its accomplishments and what action needs to be taken in this regard.

Work area 5: Policy and cross-sectoral issues

ACHIEVEMENTS IN 2002/2003

- Contributions were made and activities coordinated with the regional and global forest dialogue, notably through contributions to the Fourth Ministerial Conference on the Protection of Forests in Europe (MCPFE) and the UN Forum on Forests (see TIM/2003/4 for full details).
- A report on recent developments for forest policies and institutions was prepared in draft form for the European Forestry Commission session, discussed, revised in the light of comments received and is being prepared for publication. The EFC also identified nine "major issues confronting policy makers for the forest sector" which were transmitted to COFO.
- With regard to countries in transition, under the mandate of resolution H3 of MCPFE, the database
 on forestry assistance to countries in transition was revised and posted on the website. Its content
 is being updated on a continuing basis. A report, based on these data was published and submitted
 to the MCPFE. The Team of Specialists will meet in Poland in spring 2004.

- Country profiles were issued on countries in transition. A profile on Georgia was issued, on Ukraine is in press, on Bulgaria is in preparation and on Serbia and Montenegro is planned.
- On trade and environment issues, developments for certification were monitored (see work area 1).
 An ECE/FAO Roundtable on forest, trade and environment: working together for sustainable development was held in Geneva on 9 July 2003. The proceedings will be made available on the website shortly.
- Policy analysis continued, notably under EFSOS (see work area 3), which has stressed the cross-sectoral approach and developed new analytical tools. The format of other activities is being adapted to make them more focussed on policy issues. This is notably the case with the *Forest Products Annual Market Analysis* and the Timber Committee session itself.
- The Forest Communicators Network met in May 2003 and will meet in September 2003, during the World Forestry Congress.
- A seminar on promoting the sound use of wood was held in Romania in March 2003, which made a number of important policy recommendations for the Committee and other bodies (TIM/SEM.1/2003/2).

The following issues are brought to the attention of the Committee:

- The Committee may take note of the conclusions and recommendations of the seminar on promoting the sound use of wood and give preliminary consideration as to how they should be implemented (these proposals should be discussed in full during the Strategic Review).
- The Committee is also invited to review the outcome of the ECE/FAO roundtable on forests, trade and environment, and indicate whether this approach might be repeated.

PART II

UNECE TIMBER COMMITTEE AND FAO EUROPEAN FORESTRY COMMISSION INTEGRATED PROGRAMME OF WORK, 2003-2007

- 3. Set out below is the integrated programme of work of the Committee and the Commission for the period 2003 to 2007. Its implementation is overseen by the two bodies and their subsidiary bodies at their regular meetings, which take place on the following schedule:
- the Timber Committee meets annually;
- the European Forestry Commission (EFC) meets every two years (2004, 2006, etc.);
- the Joint FAO/ECE/ILO Committee on Forest Technology, Management and Training meets every two years (2004, 2006 etc.); and
- the Joint FAO/ECE Working Party on Forest Economics and Statistics meets every year.
- 4. The EFC Working Party on Management of Mountain Watersheds and the AFWC/EFC/NEFC Working Party on Mediterranean Forestry Questions, *Silva Mediterranea* report to the EFC, but not to the Timber Committee, so are not reported on here.
- 5. The bureaux of the Committee and the Commission meet jointly every year to oversee the implementation of the programme and prepare forthcoming sessions. The bureaux met in Geneva from 29 to 30 April 2002, the report of the meeting may be found at the website: http://www.unece.org/trade/timber/docs/bureaux/bureaux-02.htm
- 6. The integrated programme is implemented by the ECE and FAO staff in Geneva led by the Chief of the Timber Branch of the ECE Trade Development and Timber Division in close cooperation with the Forestry Department of FAO.
- 7. All activities are carried out in cooperation with partners in international organisations and countries.
- 8. The integrated programme contains five continuing work areas. In each of these, some programme elements are of a continuing nature, while others have a fixed duration and will be replaced periodically.

Work Area 1: MARKETS AND STATISTICS

Objective: Collect, analyse and disseminate information on forest products markets and forest fires in cooperation with partners in international organizations and countries. Provide for a for discussion of forest products marketing, especially in countries in transition, and on market developments and disseminate current, neutral information in order to support sustainable development in the forest products sector.

Guidance: Joint FAO/ECE Working Party on Forest Economics and Statistics

Programme elements:

- 1.1 Statistics on production, trade and prices of forest products
- 1.2 Analysis of markets for forest products
- 1.3 Capacity building for forest products marketing in countries in transition
- 1.4 Monitoring of markets for certified forest products
- 1.5 Statistics on forest fires
- 1.6 Information network, activities of team of specialists

Work Area 2: FOREST RESOURCE ASSESSMENT

Objective: Collect and make available the best possible data on the forests of the industrialised countries (ECE region, plus Australia, New Zealand and Japan). All activities will be carried out in close cooperation with the FAO global forest resource assessment programme (Global FRA).

Guidance: Joint FAO/ECE Working Party on Forest Economics and Statistics

Programme elements:

- 2.1 Collection and validation of data on forest resources, including methodological development
- 2.2 Main regional reports
- 2.3 Indicators of sustainable forest management: improve concepts, supply data
- 2.4 Contribution to global FRA
- 2.5 Country profiles of countries in transition
- 2.6 Special studies (biodiversity, forest condition, carbon flows etc.)
- 2.7 Information network, work area administration

Work Area 3: EUROPEAN FOREST SECTOR OUTLOOK STUDIES

Objective: Analyse the developments and outlook for the forest and forest industry sector, considering challenges and uncertainties of varying policies, market developments and the influence of exogenous factors. This should encompass all main kinds of forestry land use and all stages of forest product use, from the forest to the final consumer. The aim is to assist policy formulation and investment decision-making. The main target groups of EFSOS are policy makers, entrepreneurs, the academic community of the forest and forest products sector and the public.

Guidance: Joint FAO/ECE Working Party on Forest Economics and Statistics

Programme elements:

- 3.1 Outlook for European forest products markets
- 3.2 Outlook for European forest resources
- 3.3 Analysis of long-term historical driving forces
- 3.4 Case studies for countries in transition
- 3.5 Policy scenarios
- 3.6 Information network, public relations of EFSOS, fund raising

Work Area 4: TECHNOLOGY, MANAGEMENT AND TRAINING

Objective: The Joint FAO/ECE/ILO Committee on Forest Technology, Management and Training assists countries, in particular those which its parent bodies may identify at any time as requiring priority attention, to develop their forestry activities in the context of sustainable development. This is achieved by fostering international cooperation on technical, economic and organizational aspects of forest management and forest working techniques and of the training of forest workers in logging and forest operations.

Guidance: Joint FAO/ECE/ILO Committee on Forest Technology, Management and Training

Programme elements:

Note: many activities of the Joint Committee are not restricted to one work element but cut across all three topics. Harvesting, for instance, takes also into account silvicultural and environmental considerations as well as aspects of occupational safety and health. The Joint Committee co-operates with other organisations, e.g. IUFRO, whenever possible.

- 4.1 Forest technology (forest roads, harvesting and transport of wood raw material)
- 4.2 Forest management (multiple use forestry, preparation and implementation of forest management plans, information systems, silvicultural operations, forest fire prevention and control)
- 4.3 Training of forest workers (vocational training in forestry, applied ergonomics, occupational safety and health)
- 4.4 Steering Committee, work area administration

Work Area 5: POLICY AND CROSS-SECTORAL ISSUES

Objective: Monitor developments in policies and forest sector institutions, and carry out policy analysis of topics identified as important. To contribute as appropriate to the regional and global dialogue on sustainable development of the sector. Particular attention will be paid to issues of importance to countries in transition.

Guidance: Timber Committee and European Forestry Commission

Programme elements:

- 5.1 Contribution to and co-ordination of activities with the Ministerial Conference on the Protection of Forests in Europe
- 5.2 Contribution to global dialogue on forests through regional bodies such as the EFC and the MCPFE.
- 5.3 Monitoring changes in policies and institutions
- 5.4 Monitoring forestry assistance to countries in transition (monitoring of activities under resolution H3)
- 5.5 Trade and environment issues relevant to the forestry and forest products sector
- 5.6 Policy analysis
