Building on work done for the State of Europe's Forests report 2011.</p> <p>NAFSOS:</p> <ul style="list-style-type: none"> • Assemble preliminary projections deriving from GFPM on the 2010 U.S. Resources Planning Act Forest Assessment scenarios A1B and B2. Projections will include production, consumption, import, and export quantities and world prices by major product category, for the US and Canada. • Coordinate with Canadian counterparts on developing a draft document. • Seek review of the draft document.
9	Comments, lessons learned	<p>UNECE/FAO has brought together a network of experts to develop an innovative approach to a new outlook study which regards the major policy questions linked to climate change mitigation and adaptation, biodiversity protection and industrial competitiveness. Significant efforts need to be invited in understanding and ensuring compatibility between each method to ensure that results are reliable and transparent. At the same time, the methods should be clear enough to allow for an understanding of country experts and policy makers, as clearly evidenced by the feedback received at the ToS meeting.</p>
